3 75; and

5 Pat Evans was born in Stonega, Virginia, on October 7, 1945, and
6 grew up with eight younger siblings, Linda, Brenda, Doris, Leonard,
7 Roger, John, Larry, and Ronnie; she became the devoted mother of a
8 son, Bobby, and a daughter, Michelle, and she took great pride in
9 her six grandchildren, Jack, Julia, Luke, Claire, Alex, and Stuart,
10 and her great-grandchild, Henry; following the death of her husband
11 of nearly 40 years, Clive Dickey, she was fortunate enough to find
12 love again, and she married Warren Taylor; she was a steadfast
13 source of kindness, compassion, and strength for all the members of

3 secretary of the Angelina & Neches River Authority Board and as a
4 member of both the Houston County Hospital District Board and the
5 board of All Saints' Episcopal Church; moreover, she was a sponsor

7 time and talents to the Boys and Girls Club; and
