- 17 of the Judicial Education Committee of the American Probation and
- 18 Parole Association, and in 2019, he was appointed by the presiding
- 19 judge of the Texas Court of Criminal Appeals to serve on the
- 20 Judiciary Advisory Council, which provides guidance to the
- 21 Community Justice Assistance Division and the Texas Board of
- 22 Criminal Justice; and
- WHEREAS, This distinguished jurist is a member of the State
- 24 Bar of Texas and the Brazoria County Bar Association, and he is a

- 2 maintained a private practice in Angleton and served as assistant
- 3 district attorney of Brazoria County; and

- 6 Sebesta, as well as that of his five children, Patrick, William,
- 7 Christopher, Annabelle, and John; and

- 10 Brazoria County and earned him the respect and admiration of his
