10 WHEREAS, Soon after arriving in Texas, Ms. Trujillo embarked

11 upon a career with Killeen ISD that would eventually span 35 years,

12 and she served as a teacher, as an assistant principal, as

13 coordinator for Certified Personnel, and as principal of three

14 campuses, Willow Springs Elementary School, Maxdale Elementary

15 School, and Audie Murphy Middle School; she was named Administrator

16 of the Year by the Killeen Classroom Teachers Association in 1996

17 and Region 12 Association of Texas Professional Administrator of

18 the Year in 1997; she retired from the district in 2009; and

19 WHEREAS, Ms. Trujillo's husband was a three-term member of

20 the school board, and when he passed away in 2010, she was appointed

21 to complete his term; she remained on the board for 11 years,

22 earning the respect and admiration of her fellow board members as

23 well as teachers and parents in the district; she has also served on

24 the boards of the KISD Education Foundation and Communities in

- 3 Ms. Trujillo has served on the Killeen Housing Authority
- 4 Commissioners Board and the Board Development Committee of the Girl
- 5 Scouts of Central Texas; she is the recipient of numerous honors,

- 7 Bluebonnet Girl Scout Council, a 1997 Texas Women of Distinction
- 8 award from the Girl Scouts, and the 2001 Fort Hood Good Neighbor
- 9 Award; moreover, she is an active member of St. Joseph Catholic
- 10 Church; and
- 11 WHEREAS, In all her endeavors, Ms. Trujillo enjoys the love
- 12 and support of her three children, Dr. Laura A. Trujillo-Jenks,
- 13 U.S. Air Force Lieutenant Colonel Paul M. Trujillo, and Michelle C.

- 16 dedication, expertise, and commitment to excellence have greatly
- 17 benefited the students of Killeen ISD, and she may indeed reflect
