2 a close with the passing of Vincent Michael Jones of Justin on
3 August, 16, 2020, at the age of 63; and

4 WHEREAS, Vince Jones was born in Amarillo on February 3,
5 1957, to Ralph Lee Jones and Martha Sackett, and he grew up with the
6 companionship of his sister, Leighann; answering his nation's call
7 to duty, he joined the United States Navy and served for six years
8 aboard the USS *Bagley*; and

9 WHEREAS, Mr. Jones became a certified paramedic, and went on
10 to work at the Children's Hospital of Texas for nearly a decade; he
11 also served as a volunteer firefighter for many years before
12 joining the Highland Village Fire Department as a firefighter and
13 paramedic in 2002; over the course of his tenure with the
14 department, he rose to the rank of equipment operator; in addition,
15 he worked at the Texas Motor Speedway as head jump medic and at Code
16 3 Emergency Room & Urgent Care as a paramedic; he was also a Master
17 Mason in the Grand Lodge of Texas East Dallas; and

18 WHEREAS, In all his endeavors, Mr. Jones enjoyed the love and
19 support of his wife, Regina, and he took great pride in his three
20 stepchildren and seven grandchildren; and

21 WHEREAS, A devoted family man, proud military veteran, and
22 dedicated public servant, Vince Jones will forever be a source of
23 inspiration for those he leaves behind; now, therefore, be it
