1 WHEREAS, John William Hartman of Richmond, an esteemed 2 newspaperman and friend to many, passed away on May 3, 2021, at the 3 age of 79; and

WHEREAS, The son of Betty and Fred Hartman, Bill Hartman was born in Houston on July 19, 1941, and he grew up in Baytown with the companionship of his sister, Mary; he graduated from Robert E. Lee High School in 1959 and went on to earn a business administration degree from Baylor University in 1962; and

WHEREAS, While still a teenager, Mr. Hartman began working as 9 a janitor for the Baytown Sun, where his father was the editor and 10 11 publisher; after beginning his journalism career as a sports 12 reporter, he took a position as editor and publisher for the Bayshore Sun in La Porte, and he subsequently returned to the 13 14 Baytown Sun in 1965 as its general manager; he then served as editor and publisher of the Beaumont Enterprise and Journal until 1974; 15 16 that same year, he established Hartman Newspapers, Inc., with the purchase of The Herald-Coaster, which later became known as the 17 18 Fort Bend Herald; at its peak, his company owned 17 community newspapers in Texas and Oklahoma, and today it continues to operate 19 9 Texas newspapers; he further contributed to the industry as a 20 21 member of the Baseball Writers Association of America Houston 22 Chapter and as president of the Texas Daily Newspaper Association, 23 which named him the Pat Taggart Newspaper Leader of the Year in 24 2004; and

1 WHEREAS, Active in the wider community as well, Mr. Hartman 2 held leadership roles with numerous organizations, including the 3 Rosenberg-Richmond Area Chamber of Commerce, the Greater Fort Bend 4 Economic Development Council, Polly Ryon Memorial Hospital, and the 5 Rosenberg Rotary Club; moreover, he was a valued congregant of 6 St. John's United Methodist Church in Richmond; and

7 WHEREAS, Mr. Hartman was the proud father of three children, 8 Fred, Lee, and Lizz, and he doted on his six grandchildren, Drew, 9 Kate, Alex, Ella, Julia, and Blake; in his leisure hours, he enjoyed 10 playing golf, spending time outdoors, and showing Arabian horses; 11 and

WHEREAS, An engaged citizen, a devoted family man, and an admired professional, Bill Hartman lived a full and generous life, and he leaves behind a legacy that will continue to inspire all those who were privileged to know him; now, therefore, be it
