- 19 colleges, Mr. Calhoun dedicated himself to expanding access to
- 20 higher education as a member of the board of the Victoria College
- 21 Foundation, which has provided scholarships to numerous area
- 22 students; moreover, he gave generously of his time and talents
- 23 through his service on various other boards and organizations; he
- 24 was a valued congregant of First United Methodist Church as well;
