RESOLUTION

1 WHEREAS, During the early months of the COVID-19 pandemic, 2 the Texas A&M Veterinary Medical Diagnostic Laboratory, the Amarillo Pathology Group, LLP, and APG's Physicians Preferred 3 Laboratory, Ltd., came together to address the urgent community 4 5 need for accurate and timely COVID-19 testing; and WHEREAS, The demand for diagnostic testing was especially 6 acute in March 2020 and the months that followed, as communities 7 worked to track and assess the spread of the novel coronavirus; at 8 9 that time, few public health laboratories were equipped to process the number of tests that were being requested, which led to the 10 11 formation of a unique partnership between the Texas A&M Veterinary 12 Medical Diagnostic Laboratory (TVMDL) and St. Joseph Health; TVMDL, which routinely tests herds and flocks of animals for a 13 14 variety of diseases, lent its high-throughput equipment and laboratory space to St. Joseph Health staff, allowing them to begin 15 16 performing a higher volume of PCR tests at its College Station laboratory in late April 2020; and 17 18 WHEREAS, Knowing that the need for testing was also critical in the Texas Panhandle, TVMDL went on to partner with the Amarillo 19 20 Pathology Group's Physicians Preferred Laboratory (APG-PPL) to 21 provide this same service at its Amarillo laboratory; through this partnership, APG-PPL was able to perform up to 600 COVID-19 tests 22 23 each day and to deliver results to patients from 24-48 hours after

specimens were collected; the laboratory proved to be a crucial

- 4 in February 2021, TVMDL and APG-PPL were recognized with Texas A&M
- 5 AgriLife's Partnership Award; and
- 6 WHEREAS, A number of individuals were instrumental in
- 7 establishing the initial partnership between TVMDL and APG-PPL,
- 8 including TVMDL's director Dr. Bruce Akey and associate agency
- 9 director Dr. Amy Swinford and APG-PPL's medical director
- 10 Dr. Robert Todd II; also vital to this undertaking were APG-PPL
- 11 administrators who helped secure federal approval for the clinic,
- 12 Charlyn Snow and Heidi Dorman, as well as the Clinical Laboratory
- 13 Improvements Amendment (CLIA) medical director, Dr. Andrew Hoot;
- 14 and
- WHEREAS, Other TVMDL professionals, Dr. Kiril Dimitrov,
- 16 Dr. Pam Ferro, Dr. Megan Schroeder, and Dr. Owais Khan, handled
- 17 such responsibilities as ensuring the accuracy of test results and
- 18 securing testing supplies; TVMDL employees Jonatan Sanchez-Gama
- 19 and Nicholas Monday trained and assisted APG-PPL staff on the use of
- 20 the equipment, while APG-PPL employees Cliff George, Chris Kelly,
- 21 Katera Padilla, and Ashley Tarrant were tasked with delivering
- 22 human samples to the lab and performing tests; finally, a great deal
- 23 of appreciation is owed to Texas A&M AgriLife vice chancellors
- 24 Dr. Patrick J. Stover and Joe Cox and to Sandra Talton, legislative
- 25 director in the office of State Representative Four Price, for
- 26 their tremendous contributions; and
- 27 WHEREAS, The success of this collaboration is a credit to the
