10 WHEREAS, Through his dedication, expertise, and commitment 11 to excellence, Thomas Randle has helped countless young Texans 12 acquire the knowledge and skills necessary to succeed, and his 13 contributions will be remembered and appreciated for years to come; 14 now, therefore, be it
