1 WHEREAS, William David Lacy of Community Bank and Trust in
2 Waco was inducted into the Texas Bankers Hall of Fame at a ceremony
3 in Huntsville on April 22, 2021; and

4 WHEREAS, Established by the Smith-Hutson Endowed Chair of
5 Banking at Sam Houston State University, the Texas Bankers Hall of
6 Fame recognizes outstanding bankers who have worked to improve
7 their industry, their communities, and their state; and

8 WHEREAS, William Lacy is a fourth-generation bank president
9 in Waco, and his father, Walter G. Lacy Jr., was inducted into the
10 Texas Bankers Hall of Fame in 2013; after earning his bachelor's
11 degree in accounting and finance from Baylor University in 1979,
12 Mr. Lacy began his career at Community Bank and Trust, starting as a
13 teller and working his way up into auditing, information
14 technology, marketing, and commercial lending; he was subsequently
15 employed with Republic Bank Corporation and NationsBank, and in
16 1990, he returned to Community Bank and Trust, where he has served
17 as president since July 1999; and

18 WHEREAS, A leader in his profession and his community,
19 Mr. Lacy has twice served on the board of the Texas Bankers
20 Association, including a term on the executive committee, and he
21 has also contributed his time and expertise to several committees
22 of the American Bankers Association, with particular attention to
23 recruiting young people into banking; in addition, he has been a
24 member of more than 100 boards for organizations in and around Waco,

1 including the Greater Waco Chamber of Commerce, the Waco Industrial
2 Foundation, and the Texas Sports Hall of Fame; and

3 WHEREAS, In all his endeavors, Mr. Lacy benefits from the
4 love and support of his wife, Nancy, and his daughter, Carter; and

5 WHEREAS, William Lacy's dedication, integrity, and
6 commitment to excellence have greatly benefited his profession and
7 his fellow citizens, and he may indeed take pride in this special
8 recognition of his many contributions to banking in the Lone Star
9 State; now, therefore, be it

10 RESOLVED, That the House of Representatives of the 87th Texas
11 Legislature hereby congratulate William David Lacy on his induction
12 into the Texas Bankers Hall of Fame and extend to him sincere best
13 wishes for continued success; and, be it further
