- 1 WHEREAS, The Honorable Edward C. Prado has distinguished
- 2 himself through his service to our state and nation as a jurist and
- 3 as U.S. ambassador to Argentina; and
- WHEREAS, A native of San Antonio, Edward Prado earned his
- 5 bachelor's and law degrees from The University of Texas at Austin,
- 6 and he served in the U.S. Army Reserve from 1972 to 1987, retiring
- 7 at the rank of captain; he began his exemplary legal career as an
- 8 assistant district attorney in Bexar County from 1972 to 1976 and as
- 9 an assistant public defender for the Western District of Texas from
- 10 1976 to 1980, when he became judge of the 187th District Court in
- 11 Bexar County; and
- WHEREAS, After serving as U.S. attorney for the Western
- 13 District from 1981 to 1984, Judge Prado was appointed by President
- 14 Ronald Reagan as a U.S. district judge for the Western District,
- 15 serving for 19 years; in 2003, he was appointed by President George
- 16 W. Bush to the U.S. Court of Appeals for the Fifth Circuit, and he
- 17 held that post until his retirement in 2018; he has also been
- 18 appointed by the chief justice of the U.S. Supreme Court as chair of
- 19 the Criminal Justice Active Review Committee and to serve on the
- 20 board of the Federal Judicial Center, the Defender Services
- 21 Committee, and the Judicial Branch Committee of the Judicial
- 22 Conference of the United States; and
- WHEREAS, On January 17, 2018, Judge Prado was nominated by
- 24 the president to represent the United States as ambassador to the

- 1 Argentine Republic; he was confirmed by the U.S. Senate on March 22,
- 2 2018, and he served with great distinction from May 9, 2018, to
- 3 January 20, 2021; and
- WHEREAS, Judge Prado's experience, integrity, and commitment
- 5 to public service have greatly benefited both his state and his
- 6 nation, and he may indeed take great pride in his long record of
- 7 achievement; now, therefore, be it
