

R E S O L U T I O N

1           WHEREAS, During the 87th Texas Legislature, Judge Rick Hill  
2 has served as a champion for his profession through his work as  
3 president of the Justices of the Peace and Constables Association  
4 of Texas; and

5           WHEREAS, Since 1945, the JPCA has represented the interests  
6 of the justices of the peace and constables of the Lone Star State,  
7 protecting the heritage and authority of these essential offices;  
8 as president during the current legislative session, Judge Hill has  
9 advocated for legislation that is beneficial to the profession; and

10           WHEREAS, Judge Hill was elected as justice of the peace for  
11 Brazos County Precinct 3 in 2014 and elected to a second term in  
12 2018; in addition, he has served as a faculty member for the Texas  
13 Justice Court Training Center for three years; and

14           WHEREAS, A veteran of the U.S. Air Force, Judge Hill earned  
15 his bachelor's and master's degrees at Texas A&M University, and  
16 from 1989 until his retirement in 2011, he was an educator with the  
17 College Station Independent School District; at A&M Consolidated  
18 High School, he taught chemistry and physical science before  
19 becoming assistant principal, and he went on to serve for nine years  
20 as principal at Cypress Grove Intermediate School; and

21           WHEREAS, Judge Hill is widely recognized as the "Voice of  
22 Aggieland," having been the announcer for Aggie baseball at Olsen  
23 Field for 29 years and at various College Station ISD sporting  
24 events for 30 years; he has also read the names of graduates at

1 commencement ceremonies for TAMU and area high schools; in all his  
2 endeavors, he enjoys the love and support of his wife, Donna; and

3         WHEREAS, Judge Hill's dedication, expertise, and commitment  
4 to excellence have greatly benefited the mission of the JPCA and  
5 earned him the respect and admiration of the association's  
6 membership, and he may indeed take great pride in his outstanding  
7 work in their behalf during the legislative session; now,  
8 therefore, be it

9         RESOLVED, That the House of Representatives of the 87th Texas  
10 Legislature hereby commend Judge Rick Hill for his work as  
11 president of the Justices of the Peace and Constables Association  
12 of Texas and extend to him sincere best wishes for continued
