1 education program was developed under Section 29.005(b) during the 2019-2020 school year or the 2020-2021 school year and, if so, 2 whether the program was developed by the date required under 34 3 C.F.R. Section 300.323(c)(1); 4 5 (3) whether the provision of special services to the child under an individualized education program during the 6 7 2019-2020 school year or the 2020-2021 school year was interrupted, 8 reduced, delayed, suspended, or discontinued; and 9 (4) whether compensatory educational services under 10 Subchapter C are appropriate for the child based on the information under Subdivisions (1)-(3) or any other factors. 11 12 (b) Section 29.005(f) and Section 29.0051 do not apply to a supplement prepared for inclusion with a written statement of an 13 individualized education program, as required by this section. 14 15 (c) The commissioner shall adopt rules as necessary to implement this section. 16

(d) This section expires September 1, 2023.

18 SECTION 3. (a) Not later than December 1, 2021, the 19 commissioner of education shall adopt necessary rules under Section 20 29.0052, Education Code, as added by this Act.

(b) Not later than June 1, 2022, a school district subject to Section 29.0052, Education Code, as added by this Act, shall complete each required supplement to a written statement of an individualized education program, as provided by that section.

25 SECTION 4. This Act takes effect immediately if it receives 26 a vote of two-thirds of all the members elected to each house, as 27 provided by Section 39, Article III, Texas Constitution. If this
