ELIGIBILITY FOR EARLY VOTING [BY PERSONAL 15 16 APPEARANCE]. Any qualified voter is eligible for early voting by 17 mail or personal appearance. 18 SECTION 3. Section 82.007, Election Code, is amended to read as follows: 19 Sec. 82.007. PARTICIPATION IN ADDRESS CONFIDENTIALITY 20 21 PROGRAM. Notwithstanding Section 82.005, a [A] qualified voter who, [is eligible for early voting by mail if: 22 [(1) the voter submitted a registration application by 23 personal delivery as required by Section 13.002(e); and 24

[(2)] at the time the voter's early voting ballot 1 application is submitted, [the_voter] is certified 2 for 3 participation in the address confidentiality program administered by the attorney general under Subchapter B, Chapter 58, Code of 4 5 Criminal Procedure, is eligible for early voting by mail only if the voter submitted a registration application by personal delivery as 6 required by Section 13.002(e). 7

8 SECTION 4. Section 84.001(a), Election Code, is amended to 9 read as follows:

10 (a) To be entitled to vote an early voting ballot by mail, a 11 person [who is eligible for early voting] must make an application 12 for an early voting ballot to be voted by mail as provided by this 13 title.

SECTION 5. Section 84.002(a), Election Code, is amended to read as follows:

(a) An early voting ballot application must include:

17 (1) the applicant's name and the address at which the18 applicant is registered to vote;

19 (2) for an application for a ballot to be voted by mail 20 <u>by an applicant who will be absent from the applicant's</u> [on the 21 ground of absence from the] county of residence <u>on election day</u>, the 22 address outside the applicant's county of residence to which the 23 ballot is to be mailed;

(3) for an application for a ballot to be voted by mail
by an applicant who is 65 years of age or older on election day or
has a sickness or physical condition that requires the applicant to
reside in a hospital or nursing home or other long-term care

facility, or with a relative [on the ground of age or disability], 1 the address of the hospital, nursing home or other long-term care 2 3 facility, or retirement center, or of a person related to the applicant within the second degree by affinity or the third degree 4 by consanguinity, as determined under Chapter 573, Government Code, 5 if the applicant is living at that address and that address is 6 different from the address at which the applicant is registered to 7 8 vote;

9 (4) for an application for a ballot to be voted by mail 10 <u>by an applicant who is confined</u> [on the ground of confinement] in 11 jail <u>as described by Section 84.009(a)</u>, the address of the jail or 12 of a person related to the applicant within the degree described by 13 Subdivision (3); <u>and</u>

14 (5) [for an application for a ballot to be voted by 15 mail on any ground,] an indication of each election for which the 16 applicant is applying for a ballot[; and

17 [(6) an indication of the ground of eligibility for 18 early voting].

19 SECTION 6. Section 84.009, Election Code, is amended by 20 amending Subsection (a) and adding Subsection (b) to read as 21 follows:

(a) <u>This section applies only to an applicant who, at the</u>
time the application for a ballot to be voted by mail is submitted,
is confined in jail:
(1) serving a misdemeanor sentence for a term that

26 ends on or after election day;

27 (2) pending trial after denial of bail;

1 (3) without bail pending an appeal of a felony 2 conviction; or

3 (4) pending trial or appeal on a bailable offense for 4 which release on bail before election day is unlikely.

5 (b) On request of the applicant, an application for a ballot 6 to be voted by mail [on the ground of confinement in jail] may be 7 submitted to the early voting clerk, at the discretion of the 8 authority in charge of the jail, by personal delivery by the jail 9 authority or by a designated subordinate of the authority.

10 SECTION 7. Section 84.011(a), Election Code, is amended to 11 read as follows:

12 (a) The officially prescribed application form for an early13 voting ballot must include:

(1) immediately preceding the signature space the statement: "I certify that the information given in this application is true, and I understand that giving false information in this application is a crime.";

18 (2) a statement informing the applicant of the
19 offenses prescribed by Sections 84.003 and 84.004;

(3) spaces for entering an applicant's voter
registration number and county election precinct of registration,
with a statement informing the applicant that failure to furnish
that information does not invalidate the application; and

(4) on an application for a ballot to be voted by mail:
(A) a space for an applicant [applying on the
ground of absence from the county of residence] to indicate whether
the applicant will be absent from the applicant's county of

1 <u>residence on election day and, if applicable,</u> the date on or after
2 which the applicant can receive mail at the address outside the
3 county;

(B) a space for indicating the fact that an
applicant whose application is signed by a witness cannot make the
applicant's mark and a space for indicating the relationship or
lack of relationship of the witness to the applicant;

8 (C) a space for entering an applicant's telephone 9 number, with a statement informing the applicant that failure to 10 furnish that information does not invalidate the application;

11 (D) a space or box for an applicant who is 65 12 years of age or older on election day or has a sickness or physical condition that requires the applicant to reside in a hospital or 13 nursing home or other long-term care facility, or with a relative, 14 15 [applying on the ground of age or disability] to indicate that the address to which the ballot is to be mailed is the address of a 16 17 facility or relative described by Section 84.002(a)(3), if applicable; 18

(E) a space or box for an applicant <u>confined</u> [applying on the ground of confinement] in jail <u>as described by</u> <u>Section 84.009(a)</u> to indicate that the address to which the ballot is to be mailed is the address of a relative described by Section 84.002(a)(4), if applicable;

(F) a space for an applicant [applying on the
ground of age or disability] to indicate if the application is an
application under Section 86.0015;

(G) spaces for entering the signature, printed

1 name, and residence address of any person assisting the applicant;
2 (H) a statement informing the applicant of the
3 condition prescribed by Section 81.005; and

4 (I) a statement informing the applicant of the 5 requirement prescribed by Section 86.003(c).

6 SECTION 8. Sections 86.001(b) and (c), Election Code, are 7 amended to read as follows:

8 (b) If the <u>application complies with the applicable</u> 9 <u>requirements prescribed by this title</u> [applicant is entitled to 10 vote an early voting ballot by mail], the clerk shall provide an 11 official ballot to the applicant as provided by this chapter.

(c) Except as provided by Section 86.008, if the applicant is not entitled to vote <u>in the election</u> [by mail], the clerk shall reject the application, enter on the application "rejected" and the reason for and date of rejection, and deliver written notice of the reason for the rejection to the applicant at both the residence address and mailing address on the application. A ballot may not be provided to an applicant whose application is rejected.

SECTION 9. Section 86.0015(a), Election Code, is amended to read as follows:

(a) This section applies only to an application for a ballot
to be voted by mail that [+

23 [(1) indicates the ground of eligibility is age or 24 disability; and

25 [(2)] does not specify the election for which a ballot 26 is requested or has been marked by the applicant as an application 27 for more than one election.

8 (1) <u>will be absent from the voter's</u> [absence from the] 9 county of residence <u>on election day</u>, in which case the address must 10 be an address outside the voter's county of residence;

11 (2) <u>is confined</u> [confinement] in jail <u>as described by</u> 12 <u>Section 84.009(a)</u>, in which case the address must be the address of 13 the jail or of a relative described by Section 84.002(a)(4); or

SECTION 11. Section 86.004(b), Election Code, is amended to read as follows:

(b) For an election to which Section 101.104 applies, the balloting materials for a voter who indicates on the application for a ballot to be voted by mail or the federal postcard application that the voter <u>seeks</u> [is eligible] to vote early by mail as a

1 consequence of the voter's being outside the United States shall be mailed on or before the later of the 45th day before election day or 2 3 the seventh calendar day after the date the clerk receives the application. However, if it is not possible to mail the ballots by 4 5 the deadline of the 45th day before election day, the clerk shall notify the secretary of state within 24 hours of knowing that the 6 deadline will not be met. The secretary of state shall monitor the 7 8 situation and advise the clerk, who shall mail the ballots as soon as possible in accordance with the secretary of state's guidelines. 9

10 SECTION 12. Section 87.041(b), Election Code, is amended to 11 read as follows:

(b) A ballot may be accepted only if:

13 (1) the carrier envelope certificate is properly 14 executed;

15 (2) neither the voter's signature on the ballot 16 application nor the signature on the carrier envelope certificate 17 is determined to have been executed by a person other than the 18 voter, unless signed by a witness;

8 SECTION 13. Section 102.001(a), Election Code, is amended 9 to read as follows:

(a) A qualified voter is eligible to vote a late ballot as provided by this chapter if the voter has a sickness or physical condition [described by Section 82.002] that prevents the voter from appearing at the polling place on election day without a likelihood of needing personal assistance or of injuring the voter's health and originates on or after the day before the last day for submitting an application for a ballot to be voted by mail.

17 SECTION 14. Sections 82.001, 82.002, 82.003, 82.004, 18 84.002(b), and 112.002(b), Election Code, are repealed.

SECTION 15. The changes in law made by this Act apply onlyto an election ordered on or after September 1, 2021.
