13	connection with pharmacy benefits.
14	Sec. 1358.102. APPLICABILITY OF SUBCHAPTER. (a) This
15	subchapter applies only to a health benefit plan that provides
16	benefits for medical or surgical expenses incurred as a result of a
17	health condition, accident, or sickness, including an individual,
18	group, blanket, or franchise insurance policy or insurance
19	agreement, a group hospital service contract, or an individual or
20	group evidence of coverage or similar coverage document that is
21	issued by:
22	(1) an insurance company;

A health benefit plan may not impose a cost-sharing provision for 16 17 insulin if the total amount the enrollee is required to pay exceeds \$25 for a 30-day supply. 18 19 Sec. 1358.104. LIMITATION ON PHARMACY CONTRACTS. contract between a health benefit plan issuer or pharmacy benefit 20 manager and a pharmacy may not contain a provision: 21 22 (1) authorizing the issuer's pharmacy benefit manager or the pharmacy to charge an amount for insulin greater than the 23 24 amount described by Section 1358.103; 25 (2) requiring the pharmacy to collect an amount for 26 insulin greater than the amount described by Section 1358.103; or

(3) requiring an enrollee to make a cost-sharing

- 1 payment for covered insulin in an amount that exceeds the amount
- 2 described by Section 1358.103.
- 3 SECTION 2. (a) Section 1358.103, Insurance Code, as added
- 4 by this Act, applies only to a health benefit plan that is
- 5 delivered, issued for delivery, or renewed on or after January 1,
- 6 2022. A health benefit plan delivered, issued for delivery, or
- 7 renewed before January 1, 2022, is governed by the law as it existed
- 8 immediately before the effective date of this Act, and that law is
- 9 continued in effect for that purpose.
- 10 (b) Section 1358.104, Insurance Code, as added by this Act,
- 11 applies only to a contract entered into or renewed on or after the
- 12 effective date of this Act.
- SECTION 3. This Act takes effect September 1, 2021.
