4 SECTION 1. Section 2(a)(1), Article 37.071, Code of 5 Criminal Procedure, is amended to read as follows:

If a defendant is tried for a capital offense in

8 defendant is guilty of a capital offense, the court shall conduct a

separate sentencing proceeding to determine whether the defendant

10 shall be sentenced to death or life imprisonment without

11 parole. The proceeding shall be conducted in the trial court and,

12 except as provided by Article 44.29(c) [of this code], before the

13 trial jury as soon as practicable. In the proceeding, evidence may

be presented by the state and the defendant or the defendant's

15 counsel as to any matter that the court deems relevant to sentence,

16 including evidence of the defendant's background or character or

17 the circumstances of the offense that mitigates against the

19 construed to authorize the introduction of any evidence secured in

- 7 SECTION 4. The change in law made by this Act applies only
- 8 to a criminal proceeding that commences on or after the effective
- 9 date of this Act. A criminal proceeding that commenced before the
- 10 effective date of this Act is governed by the law in effect on the
- 11 date the proceeding commenced, and the former law is continued in
- 12 effect for that purpose.
- SECTION 5. This Act takes effect September 1, 2021.
