- SECTION 1. Section 51.014(a), Civil Practice and Remedies 5
- 6 Code, is amended to read as follows:

- SECTION 2. Sections 74.351(a) and (c), Civil Practice and
- 27 Remedies Code, are amended to read as follows:

- 1 In a health care liability claim, a claimant shall, not 2 later than the 120th day after the date each defendant's original answer is filed or a later date required under Section 74.353, serve 3 4 on that party or the party's attorney one or more expert reports, with a curriculum vitae of each expert listed in the report for each 5 physician or health care provider against whom a liability claim is 6 7 asserted. The date for serving the report may be extended by written agreement of the affected parties. Each defendant 8 physician or health care provider whose conduct is implicated in a report must file and serve any objection to the sufficiency of the 10 11 report not later than the later of the 21st day after the date the report is served or the 21st day after the date the defendant's 12 13 answer is filed, failing which all objections are waived.
- If an expert report has not been served within the 14 period specified by Subsection (a) because elements of the report 15 16 are found deficient, the court may grant one 30-day extension to the claimant in order to cure the deficiency. If the claimant does not 17 receive notice of the court's ruling granting the extension until 18 after the applicable [120-day] deadline has passed, then the 30-day 19 20 extension shall run from the date the plaintiff first received the notice. 21
- SECTION 3. Subchapter H, Chapter 74, Civil Practice and Remedies Code, is amended by adding Section 74.353 to read as follows:
- Sec. 74.353. PRELIMINARY DETERMINATION FOR EXPERT REPORT
 REQUIREMENT. (a) On motion of a claimant filed not later than 30
 days after the date each defendant's original answer is filed, a

- 1 court may issue a preliminary determination regarding whether a
- 2 claim made by the claimant is a health care liability claim for the
- 3 purposes of Section 74.351.
- 4 (b) If a court determines under Subsection (a) or (c) that a
- 5 claim is a health care liability claim for purposes of Section
- 6 74.351, the claimant shall serve an expert report as required by
- 7 Section 74.351 not later than the later of:
- 8 <u>(1) 120 days after the date each defendant's original</u>
- 9 answer is filed;
- 10 (2) 60 days after the date the court issues the
- 11 preliminary determination under Subsection (a) or (c); or
- 12 (3) a date agreed to in writing by the affected
- 13 parties.
- 14 (c) If a court does not issue a preliminary determination
- 15 under Subsection (a) before the 91st day after the date that a
- 16 claimant files a motion under that subsection, the court shall
- 17 <u>issue a preliminary determination that the claim is a health care</u>
- 18 liability claim for the purposes of Section 74.351.
- 19 (d) A preliminary determination under this section is
- 20 subject to interlocutory appeal by either the claimant or
- 21 defendant.
- (e) If on interlocutory appeal an appellate court reverses a
- 23 trial court's preliminary determination that a claim is not a
- 24 health care liability claim, the claimant shall serve an expert
- 25 report as required by Section 74.351 not later than 120 days after
- 26 the date that the appellate court issues an opinion reversing the
- 27 preliminary determination.

- 1 (f) A preliminary determination under this section applies
- 2 only to the issue of whether a claimant is required to serve an
- 3 expert report under Section 74.351.
- 4 SECTION 4. The change in law made by this Act applies only
- 5 to an action commenced on or after the effective date of this Act.
- 6 An action commenced before the effective date of this Act is
- 7 governed by the law as it existed immediately before the effective
- 8 date of this Act, and that law is continued in effect for that
- 9 purpose.
- 10 SECTION 5. This Act takes effect September 1, 2021.
