(a) A rule or policy adopted 9 or a penalty imposed under this chapter may not: 10 11 (1) limit an applicant's ability to obtain a license to 12 practice law in this state, or a state bar member's ability to maintain or renew the license, based on a sincerely held religious 13 14 belief of the applicant or state bar member; or 15 (2) burden an applicant's or state bar member's: (A) free exercise of religion, regardless of 16 whether the burden is the result of a rule or policy generally 17 applicable to all applicants or state bar members; 18 (B) freedom of speech regarding a sincerely held 19 religious belief; 20 21 (C) membership in any religious organization; or 22 (D) freedom of association. 23 (b) Subsection (a) does not apply to a state bar rule or policy adopted or penalty imposed under this chapter that results 24

2	policy, or penalty is:
3	(1) essential to enforcing a compelling governmental

5	(2) narrowly tailored to accomplish that purpose.
6	(c) A person may assert that a state bar rule or policy
7	adopted or penalty imposed under this chapter violates Subsection
8	(a) as a defense in an administrative hearing or as a claim or
9	defense in a judicial proceeding under Chapter 37, Civil Practice
10	and Remedies Code, except that the person may not assert the
11	violation as a defense to:
12	(1) an allegation of sexual misconduct; or
13	(2) prosecution of an offense.
14	(d) A person may bring an action for injunctive relief for a
15	violation of Subsection (a).
16	SECTION 2. This Act takes effect immediately if it receives
17	a vote of two-thirds of all the members elected to each house, as
18	provided by Section 39, Article III, Texas Constitution. If this
19	Act does not receive the vote necessary for immediate effect, this
20	Act takes effect September 1, 2021.
