Unless otherwise provided by this 9 chapter, the comptroller shall conduct all hearings required by 10 11 this chapter in accordance with Chapter 2001, Government Code. The comptroller may designate one or more representatives to conduct 12 13 the hearings and may prescribe the rules of procedure governing the 14 hearings. 15 Sec. 147.0004. RULES.
