5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subchapter G, Chapter 38, Education Code, is
7	amended by adding Section 38.353 to read as follows:
8	Sec. 38.353. SUICIDE PREVENTION INFORMATION REQUIRED ON
9	CERTAIN STUDENT IDENTIFICATION CARDS. Each student identification
10	card issued by a public school to a student in grade seven or
11	higher:
12	(1) must have printed on either side of the card the
13	telephone number for the National Suicide Prevention Lifeline; and
14	(2) may have printed on either side of the card the
15	telephone number for:
16	(A) the Crisis Text Line; and
17	(B) a local suicide prevention hotline, if
18	available.
19	SECTION 2. Subchapter ${\tt Z}$, Chapter ${\tt 51}$, Education Code, is
20	amended by adding Section 51.91941 to read as follows:
21	Sec. 51.91941. SUICIDE PREVENTION INFORMATION REQUIRED ON
22	STUDENT IDENTIFICATION CARD. (a) In this section, "institution of
23	higher education" has the meaning assigned by Section 61.003.
24	(b) Each student identification card issued by an

- 2 (1) must have printed on either side of the card the
- 3 telephone number for:
- 4 (A) the National Suicide Prevention Lifeline;
- 5 and
- 6 (B) the campus police department or security for
- 7 the campus at which the student to whom the card is issued regularly
- 8 attends classes or, if the campus does not have a campus police
- 9 department or security, a local nonemergency police contact; and
- 10 (2) may have printed on either side of the card the
- 11 <u>telephone number for:</u>
- 12 (A) the Crisis Text Line; and
- 13 (B) a local suicide prevention hotline, if
- 14 <u>available</u>.
- 15 SECTION 3. (a) Notwithstanding Sections 38.353 and
- 16 51.91941, Education Code, as added by this Act, if, on January 1,
- 17 2022, a public school or a public institution of higher education
- 18 subject to the requirements of Section 38.353 or 51.91941,
- 19 Education Code, as applicable, has a supply of unissued student
- 20 identification cards that do not comply with the applicable
- 21 requirements of those sections, the public school or public
- 22 institution of higher education may issue those student
- 23 identification cards until the supply of cards is depleted.
- (b) Sections 38.353 and 51.91941, Education Code, as added
- 25 by this Act, apply only to an initial or replacement student
- 26 identification card issued on or after June 1, 2022.
- 27 SECTION 4. This Act takes effect immediately if it receives

- 1 a vote of two-thirds of all the members elected to each house, as
- 2 provided by Section 39, Article III, Texas Constitution. If this
- 3 Act does not receive the vote necessary for immediate effect, this
- 4 Act takes effect September 1, 2021.
