Chapter 38, Code of Criminal Procedure, 5 is 6 amended by adding Article 38.24 to read as follows: Art. 38.24. STATEMENTS OBTAINED BY INVESTIGATIVE HYPNOSIS. 7 (a) In this article, "investigative hypnosis" means a technique 8 9 that uses hypnosis to explore the memory of a witness to enhance the witness's recall of a legally relevant event, including 10 descriptions of people, conversations, and the environment. 11 12 (b) This article applies to all statements made during or after a hypnotic session by a person who has undergone 13 investigative hypnosis for the purpose of enhancing the person's 14 15 recollection of an event at issue in a criminal investigation or case, including courtroom testimony regarding those statements and 16 17 including statements identifying an accused that are made pursuant 18 to pretrial identification procedures. (c) A statement described by Subsection (b) is not 19 20 admissible against a defendant in a criminal trial, whether offered in the guilt or innocence phase or the punishment phase of the 21 trial. Notwithstanding Article 38.23, this article does not affect 22 the admissibility of any physical evidence, or the testimony of any 23 24 witness identified, that independently corroborates the crime.

1 SECTION 2. The change in law made by this Act applies to the 2 admissibility of a statement in a criminal proceeding that 3 commences on or after the effective date of this Act. The 4 admissibility of a statement in a criminal proceeding that 5 commences before the effective date of this Act is governed by the 6 law in effect on the date the proceeding commenced, and the former 7 law is continued in effect for that purpose.

8 SECTION 3. This Act takes effect September 1, 2021.
