5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

6 SECTION 1. Section 151.054, Tax Code, is amended by

amending Subsection (e) and adding Subsection (f) to read as

- 9 (e) Properly completed resale or exemption certificates
- 10 should be in the possession of the seller at the time the nontaxable

11 transaction occurs. If the seller is not in possession of these

12 certificates within 90 [60] days from the date written notice

13 requiring possession of them is given to the seller by the

14 comptroller or a later date agreed to by the comptroller and the

15 <u>seller</u>, deductions claimed by the seller that require delivery of

16 the certificates shall be disallowed. [If the seller delivers the

17 certificates to the comptroller within the 60-day period, the

18 comptroller may verify the reason or basis for exemption claimed in

19 the certificates before allowing any deductions. A deduction may

20 not be granted on the basis of certificates delivered to the

21 comptroller after the 90-day [60-day] period or, if applicable, the

22 date agreed to by the comptroller and the seller.

23 <u>(f) Before allowing a deduction, the comptroller may verify</u>

24 the reason or basis for exemption claimed in a resale or exemption

- 2 by Subsection (e).
- 3 SECTION 2. Section 151.104, Tax Code, is amended by
- 4 amending Subsection (d) and adding Subsection (e) to read as
- 5 follows:
- 6 (d) Properly executed resale or exemption certificates
- 7 should be in possession of the seller at the time the nontaxable
- 8 transaction occurs. If the seller is not in possession of these
- 9 certificates within $\underline{90}$ [$\overline{60}$] days from the date written notice
- 10 requiring possession of them is given to the seller by the
- 11 comptroller or a later date agreed to by the comptroller and the
- 12 <u>seller</u>, deductions claimed by the seller that require delivery of
- 13 the certificates shall be disallowed. [If the seller acquires
- 14 certificates within the 60-day period, the comptroller may verify
- 15 the reason or basis for exemption claimed in the certificates
- 16 before allowing any deductions. A deduction may not be granted on
- 17 the basis of certificates obtained after the 90-day [60-day] period
- 18 or, if applicable, the date agreed to by the comptroller and the
- 19 seller.
- 20 (e) Before allowing a deduction, the comptroller may verify
- 21 the reason or basis for exemption claimed in a resale or exemption
- 22 certificate acquired by the seller during the period provided by
- 23 Subsection (d).
- 24 SECTION 3. Sections 151.054 and 151.104, Tax Code, as
- 25 amended by this Act, apply to an audit of a seller's sales
- 26 transactions that is pending on or commenced on or after the
- 27 effective date of this Act.

SECTION 4. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2021.
