- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Subchapter A, Chapter 302, Labor Code, is
- 7 amended by adding Section 302.00341 to read as follows:
- 8 Sec. 302.00341. GRANTS TO FACILITATE PARTICIPATION IN
- 9 <u>APPRENTICESHIP TRAINING PROGRAMS BY CERTAIN VETERANS AND MILITARY</u>
- 10 PERSONNEL. (a) In this section:
- 11 (1) "Apprenticeship training program" has the meaning
- 12 assigned by Section 133.001, Education Code.
- 13 (2) "Nonprofit organization" means an organization
- 14 exempt from federal income taxation under Section 501(a), Internal
- 15 Revenue Code of 1986, as an organization described by Section
- 16 501(c)(3) of that code.
- 17 (b) The commission shall develop and administer a program
- 18 under which the commission may award grants to one or more nonprofit
- 19 organizations that facilitate the participation in apprenticeship
- 20 training programs of veterans and active duty military service
- 21 members who are transitioning into civilian employment.
- 22 (c) A grant awarded under this section may be used only to
- 23 recruit or assist veterans or active duty military service members
- 24 who are transitioning into civilian employment to participate in an

- 1 apprenticeship training program in this state.
- 2 (d) The commission shall adopt rules for the administration
- 3 of this section, including rules for verifying that state funds
- 4 awarded to a nonprofit organization under this section are being
- 5 used appropriately.
- 6 SECTION 2. As soon as practicable after the effective date
- 7 of this Act, the Texas Workforce Commission shall adopt rules under
- 8 Section 302.00341, Labor Code, as added by this Act.
- 9 SECTION 3. The Texas Workforce Commission is required to
- 10 implement this Act only if the legislature appropriates money
- 11 specifically for that purpose. If the legislature does not
- 12 appropriate money specifically for that purpose, the commission
- 13 may, but is not required to, implement this Act using other
- 14 appropriations available for that purpose.
- 15 SECTION 4. This Act takes effect September 1, 2021.
