5	SECTION 1. Subtitle G, Title 8, Insurance Code, is amended
6	by adding Chapter 1511 to read as follows:
7	CHAPTER 1511. COVERAGE OF PREEXISTING CONDITIONS
8	Sec. 1511.001. DEFINITION. In this chapter, "preexisting
9	condition" means a condition, including a diagnosis of coronavirus
10	disease (COVID-19) or a related symptom or condition, present
11	before the effective date of an individual's coverage under a
12	health benefit plan.
13	Sec. 1511.002. APPLICABILITY OF CHAPTER. (a) This chapter
14	applies only to a health benefit plan that provides benefits for
15	medical or surgical expenses incurred as a result of a health
16	condition, accident, or sickness, including an individual, group,
17	blanket, or franchise insurance policy or insurance agreement, a
18	group hospital service contract, or an individual or group evidence
19	of coverage or similar coverage document that is offered by:
20	(1) an insurance company;
21	(2) a group hospital service corporation operating
22	under Chapter 842;
23	(3) a health maintenance organization operating under
24	Chapter 843;

2	holds a certificate of authority under Chapter 844;

EXCEPTIONS. This chapter does not apply to: (1) a plan that provides coverage: 20 21 (A) only for a specified disease or for another 22 limited benefit; 23 (B) only for accidental death or dismemberment; 24 (C) for wages or payments in lieu of wages for a period during which an employee is absent from work because of 25 26 sickness or injury; 27 (D) as a supplement to a liability insurance

3	(F) only for dental or vision care; or
4	(G) only for indemnity for hospital confinement;
5	(2) a Medicare supplemental policy as defined by
6	<pre>Section 1882(g)(1), Social Security Act (42 U.S.C. Section 1395ss);</pre>
7	(3) a workers' compensation insurance policy;
8	(4) medical payment insurance coverage provided under
9	a motor vehicle insurance policy; or
10	(5) a long-term care insurance policy, including a
11	nursing home fixed indemnity policy, unless the commissioner
12	determines that the policy provides benefit coverage so
13	comprehensive that the policy is a health benefit plan as described
14	by Section 1511.002.
15	Sec. 1511.004. PREEXISTING CONDITION RESTRICTIONS
16	PROHIBITED. Notwithstanding any other law, a health benefit plan
17	issuer may not:
18	(1) deny coverage to or refuse to enroll an individual
19	in a health benefit plan on the basis of a preexisting condition;
20	(2) limit or exclude coverage under the health benefit
21	plan for treatment of the individual's preexisting condition
22	otherwise covered under the plan; or
23	(3) charge the individual more for coverage than the
24	health benefit plan issuer charges an individual who does not have a
25	preexisting condition.
26	SECTION 2. If before implementing any provision of this Act
27	a state agency determines that a waiver or authorization from a

1 federal agency is necessary for implementation of that provision,
2 the agency affected by the provision shall request the waiver or
3 authorization and may delay implementing that provision until the
4 waiver or authorization is granted.

5 SECTION 3. The change in law made by this Act applies only 6 to a health benefit plan that is delivered, issued for delivery, or 7 renewed on or after January 1, 2022. A health benefit plan that is 8 delivered, issued for delivery, or renewed before January 1, 2022, 9 is governed by the law as it existed immediately before the 10 effective date of this Act, and that law is continued in effect for 11 that purpose.

SECTION 4. This Act takes effect September 1, 2021.
