1 AN ACT 2 relating to personal protective equipment management and the a personal protective equipment advisory 3 establishment of 4 committee. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 5 6 SECTION 1. Chapter 81, Health and Safety Code, is amended by 7 adding Subchapter K to read as follows: 8 SUBCHAPTER K. PERSONAL PROTECTIVE EQUIPMENT 9 Sec. 81.451. DEFINITIONS. In this subchapter: (1) "Advisory committee" means the Personal 10 Protective Equipment Advisory Committee established under Section 11 81.453. This subdivision expires September 1, 2023. 12 (2) "Division" means the Texas Division of Emergency 13 14 Management. (3) "Essent<u>ial personnel" means:</u> 15 16 (A) government employees or personnel at a primary or secondary school, a child-care facility defined by 17 Section 42.002, Human Resources Code, or a corrections facility 18 defined by Section 89.101, who are expected to continue working 19 through a public health disaster or other public health emergency; 20 21 (B) electric and gas utility employees; or 22 (C) personnel the division considers vital to 23 public health and safety or economic and national security. (4) "Health care worker" means any individual who 24

No. 437 provides health care services to patients or provides support 1 services to those health care providers, including physicians, 2 pharmacists, dentists, clinicians, nurses, aides, home hospice 3 care providers, technicians, janitorial and housekeeping staff, 4 5 food service workers, and nonmanagerial administrative staff. 6 (5) "Personal protective equipment" means specialized 7 clothing or equipment, including masks, gloves, and gowns, worn for 8 protection against infectious materials. 9 Sec. 81.452. PERSONAL PROTECTIVE EQUIPMENT STANDARDS. (a) The division by rule shall establish guidelines for 10 the procurement, storage, and distribution of personal protective 11 12 equipment. (b) At a minimum, the division, when adopting rules under 13 14 this section, must consider: 15 (1) the types of personal protective equipment that may be required during a public health disaster or other public 16 17 health emergency; (2) the length of time each type of personal 18 19 protective equipment remains usable and the procedures for restocking a portion of each type of equipment; 20 21 (3) the amount of each type of personal protective equipment required to supply all health care workers and essential 22 personnel in this state with the equipment for 60 days during a 23 24 public health disaster or other public health emergency; 25 (4) successes and failures during previous public 26 health disasters and other public health emergencies in this state, 27 including successes and failures regarding procurement, storage,

This 23 24 subsection expires September 1, 2023. (c) The guidelines for personal protective equipment 25 26 standards adopted under this section may not be less protective or stringent than federal, state, or local guidelines on personal 27

(a) The division shall establish the Personal 3 Protective Equipment Advisory Committee composed of the following 4 5 members appointed by the division: (1) one representative of an association representing 6 7 different types of hospitals and health systems; 8 (2) one representative of an association representing nursing facilities; 9 10 (3) one representative of an association representing primary care clinics; 11 12 (4) one representative of an association representing 13 nurses; 14 (5) one representative of an association representing 15 home hospice care providers; 16 (6) one representative of a statewide association 17 representing physicians; 18 (7) two representatives of labor organizations that 19 represent essential personnel; 20 (8) one representative from the personal protective equipment manufacturing industry; 21 22 (9) one consumer representative; (10) one representative from an association 23 24 representing counties; 25 (11) one representative from the department; 26 (12) one representative from the division; and 27 (13) one representative from the commission.

(b) The advisory committee shall make recommendations to
the division as necessary on adopting rules under Section 81.452.

3 (c) This section expires and the advisory committee is 4 abolished September 1, 2023.

5 SECTION 2. (a) The Texas Division of Emergency Management 6 shall adopt rules necessary to implement Section 81.452, Health and 7 Safety Code, as added by this Act, not later than September 1, 2022.

8 (b) As soon as practicable after the effective date of this 9 Act, the Texas Division of Emergency Management shall appoint 10 members to the Personal Protective Equipment Advisory Committee 11 established under Section 81.453, Health and Safety Code, as added 12 by this Act.

13 SECTION 3. This Act takes effect immediately if it receives 14 a vote of two-thirds of all the members elected to each house, as 15 provided by Section 39, Article III, Texas Constitution. If this 16 Act does not receive the vote necessary for immediate effect, this 17 Act takes effect September 1, 2021.
