AN ACT relating to the donation of juror reimbursements.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

4 SECTION 1. Sections 61.003(a) and (c), Government Code, are

5 amended to read as follows:

- 6 (a) Each person who reports for jury service shall be 7 personally provided a form letter that when signed by the person 8 directs the county treasurer to donate all, or a specific amount
- 9 designated by the person, of the person's daily reimbursement under
- 10 this chapter to:
- 11 (1) the compensation to victims of crime fund
- 12 established under Subchapter J, Chapter 56B, Code of Criminal
- 13 Procedure;
- 14 (2) the child welfare, child protective services, or
- 15 child services board of the county appointed under Section 264.005,
- 16 Family Code, that serves abused and neglected children;
- 17 (3) any program selected by the commissioners court
- 18 that is operated by a public or private nonprofit organization and
- 19 that provides shelter and services to victims of family violence;
- 20 (4) any other program approved by the commissioners
- 21 court of the county, including a program established under Article
- 22 56A.205, Code of Criminal Procedure, that offers psychological
- 23 counseling in criminal cases involving graphic evidence or
- 24 testimony; [or]

- 1 (5) a veterans court program established by the
- 2 commissioners court as provided by Chapter 124; or
- 3 (6) a veterans county service office established by
- 4 the commissioners court as provided by Subchapter B, Chapter 434.
- 5 (c) The county treasurer shall:
- 6 (1) send all donations made under Subsection (a)(1) to
- 7 the comptroller, at the time and in the manner prescribed by the
- 8 attorney general, for deposit to the credit of the compensation to
- 9 victims of crime fund;
- 10 (2) deposit donations made to the county child welfare
- 11 board under Subsection (a)(2) in a fund established by the county to
- 12 be used by the child welfare board in a manner authorized by the
- 13 commissioners court of the county; and
- 14 (3) send all donations made under Subsection (a)(3),
- 15  $[\frac{or}{a}]$  (a)(4), or (a)(6) directly to the program or office, as
- 16 applicable, specified on the form letter signed by the person who
- 17 reported for jury service.
- 18 SECTION 2. Section 434.032, Government Code, is amended by
- 19 adding Subsection (c) to read as follows:
- 20 (c) The commissioners court of a county that maintains an
- 21 office:
- (1) may not consider a juror's donation to the office
- 23 of the juror's daily reimbursement under Section 61.003 for
- 24 purposes of determining the county's budget for the office; and
- (2) may use donations described by Subdivision (1)
- 26 only to supplement, rather than supplant, amounts budgeted by the
- 27 county for the office.
