(2) analyze the procedures for filing complaints
 against group homes and make recommendations to expedite complaint
 processes;

4 (3) analyze complaints filed against group homes in5 the preceding 10 years;

6 (4) analyze the enforcement authority over group homes 7 granted to state and local governmental agencies, including the 8 authority of counties and municipalities to enforce boarding home 9 regulations;

10 (5) recommend whether additional state and local 11 governmental enforcement authority over group homes is needed;

12 (6) recommend processes to expedite the licensing of13 and regulatory procedures for group homes;

14 (7) determine whether new categories of group homes 15 should be licensed or regulated by state or local governmental 16 agencies;

17 (8) discuss and recommend methods for identifying18 unlicensed group homes; and

evaluate whether Section 260.011, (9) Health 19 and 20 Safety Code, which prohibits a county or municipality from excluding boarding home facilities from residential areas by zoning 21 22 and similar regulations, prevents certain counties and municipalities from regulating boarding home facilities. 23

(c) Not later than December 1, 2022, the Health and Human
Services Commission shall prepare a written or electronic report
that includes a summary of the results of the study conducted under
this section and any legislative recommendations based on the study

1 and submit the report to the governor, lieutenant governor, speaker 2 of the house of representatives, and members of the standing 3 committees of the senate and the house of representatives with 4 jurisdiction over the Health and Human Services Commission.

5 SECTION 3. This Act takes effect September 1, 2021.
