A BILL TO BE ENTITLED

1	AN ACT

- 2 relating to the transfer of certain state property from the Texas
- 3 Department of Criminal Justice to Stephens County.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. (a) As soon as practicable, the Texas Department
- 6 of Criminal Justice shall transfer to Stephens County the real
- 7 property interests of the State of Texas and the department in the
- 8 tracts of land described by Subsection (f) of this section.
- 9 (b) Stephens County may use the property transferred under
- 10 this Act only for a purpose that benefits the public. If Stephens
- 11 County uses the property for any purpose other than a purpose
- 12 described by this subsection, ownership of the property
- 13 automatically reverts to the State of Texas.
- 14 (c) The Texas Department of Criminal Justice shall transfer
- 15 the property by an appropriate instrument of transfer. The
- 16 instrument of transfer must:
- 17 (1) provide that:
- 18 (A) Stephens County may use the property only for
- 19 a purpose that benefits the public; and
- 20 (B) ownership of the property will automatically
- 21 revert to the State of Texas if Stephens County uses the property
- 22 for any purpose other than a purpose described by Paragraph (A) of
- 23 this subdivision; and
- 24 (2) describe the property to be transferred by metes

- 1 and bounds.
- 2 (d) The Texas Department of Criminal Justice shall retain
- 3 custody of the instrument of transfer after the instrument of
- 4 transfer is filed in the real property records of Stephens County.
- 5 (e) Sections 31.158 and 31.159, Natural Resources Code, do
- 6 not apply to the transfer of real property authorized by this Act.
- 7 (f) The tracts of land referred to in this section are
- 8 described as follows:
- 9 (1) 149.04 acres of land out of T. E. & L. 1177, A-1948
- 10 and A. B. & M. Survey 2, A-1586, Stephens County, Texas, and being
- 11 part of a tract of land described in deed recorded in Volume 1071
- 12 Page 186 Official Public Records, Stephens County, Texas.
- 13 BEGINNING at the northeast corner of T. E. & L. 1177 and at an
- 14 interior corner of A. B. & M. Survey 2;
- 15 THENCE N 89°47'36" E with the north line of the tract described in
- 16 Volume 1071 Page 186 and the south line of the tract described in
- 17 Volume 1747 Page 3 a distance of 1907.46' to a 1/2" iron pin found in
- 18 the east line of Survey 2 A. B. & M. for the northeast corner of the
- 19 tract described in Volume 1071 and the southeast corner of the tract
- 20 described in Volume 1747 Page 3 for the northeast corner of this
- 21 tract;
- 22 THENCE S $00^{\circ}56'23"$ W with the east line of Survey 2 A. B. & M. a
- 23 distance of 747.17' to a 1/2" iron pin found for a corner in the
- 24 north line of County Road 173;
- 25 THENCE S 00°10'58" W continuing with the east line of Survey 2 A. B.
- 26 & M. and County Road 173 a distance of 1114.50' to a 1/2" iron pin
- 27 set for the northeast corner of a tract of land described in Volume

- 1 1072 Page 285 and being the eastern most southeast corner of the
- 2 tract described in Volume 1071 Page 186;
- 3 THENCE N $89^{\circ}49'02''$ W a distance of 1897.55' to a 1/2'' iron pin set in
- 4 the east line of T. E. & L. 1177 for the northwest corner of the
- 5 tract described in Volume 1072 Page 285 and being an interior corner
- 6 of this tract;
- 7 THENCE S $00^{\circ}10'58"$ W with the east line of T. E. & L. 1177 a distance
- 8 of 56.03' to a 1/2 iron pin set in the north line of an existing
- 9 road;
- 10 THENCE N 88°55'23" W with an existing fence line on the north line of
- 11 the road a distance of 1571.09' to a fence corner found for the
- 12 southwest corner of this tract;
- 13 THENCE N $00^{\circ}03'36''$ E a distance of 1869.57' to a 1/2" iron pin set in
- 14 the north lien of T. E. & L. 1177 and the south line of Survey 2 A. B.
- 15 & M. for the northwest corner of this tract;
- 16 THENCE N $89^{\circ}47'52''$ E with the north line of T. E. & L. 1177 and the
- 17 south line of Survey 2 A. B. & M. a distance of 1574.93' to the place
- 18 of beginning and containing 149.04 acres of land; and
- 19 (2) 139.76 acres of land out of T. E. & L. 1177,
- 20 A-1948, Stephens County, Texas, and being part of a tract of land
- 21 described in deed recorded in Volume 1071 Page 186, Official Public
- 22 Records, Stephens County, Texas.
- 23 BEGINNING at a 1/2" iron pin found in County Road 173 for the
- 24 southeast corner of T. E. & L. 1177 and being the southern most
- 25 southeast corner of the tract described in Volume 1071 Page 186 for
- 26 the southeast corner of this tract;
- 27 THENCE N 89°56'48" W with the south line of T. E. & L. 1177 a distance

- 1 of 3536.23' to a 1/2" iron pin fond for the southeast corner of
- 2 Tract 2 as described in Volume 1072 Page 288 Page and being the
- 3 southwest corner of this tract;
- 4 THENCE N $00^{\circ}00'42"$ E passing the northeast corner of the Tract 2 as
- 5 described in Volume 1072 Page 288 at a distance of 275.00' and
- 6 continuing a total distance of 1668.83' to a 1/2" iron pin set for
- 7 the northwest corner of this tract;
- 8 THENCE S 89°57'24" E a distance of 1840.87' to a fence corner;
- 9 THENCE N $35^{\circ}39'30''$ E a distance of 153.47' to a fence corner in the
- 10 south line of an existing road;
- 11 THENCE S 88°50'58" E with the fence on the south line the road a
- 12 distance of 1611.50' to a 1/2" iron pin set in the east line of T. E.
- 13 & L. 1177 and in County Road 173 for the northeast corner of this
- 14 tract;
- 15 THENCE S $00^{\circ}10'58"$ W with the east line of T. E. & L. 1177 and the
- 16 county road a distance of 1763.07' to the place of beginning and
- 17 containing 139.76 acres of land.
- 18 SECTION 2. This Act takes effect immediately if it receives
- 19 a vote of two-thirds of all the members elected to each house, as
- 20 provided by Section 39, Article III, Texas Constitution. If this
- 21 Act does not receive the vote necessary for immediate effect, this
- 22 Act takes effect September 1, 2021.
