1 loss; 2 (4) a state jail felony if the amount of pecuniary loss 3 is: 4 (A) \$2,500 or more but less than \$30,000; 5 less than \$2,500, if the property damaged or (B) destroyed is a habitation and if the damage or destruction is caused 6 7 by a firearm or explosive weapon; less than \$2,500, if the property was a fence (C) 8 9 used for the production or containment of: 10 (i) cattle, bison, horses, sheep, swine, 11 goats, exotic livestock, or exotic poultry; or (ii) game animals as that term is defined by 12 Section 63.001, Parks and Wildlife Code; or 13 less than \$30,000 and the actor: 14 (D) 15 (i) causes wholly or partly impairment or 16 interruption of property used for flood control purposes or a dam or of public communications, public transportation, public gas or 17 power supply, or other public service; or 18 (ii) causes to be diverted wholly, partly, 19 20 or in any manner, including installation or removal of any device for any such purpose, any public communications or public gas or 21 power supply; 22 a felony of the third degree if: 23 (5) the amount of the pecuniary loss is \$30,000 24 (A) 25 or more but less than \$150,000; [or] the actor, by discharging a firearm or other 26 (B) 27 weapon or by any other means, causes the death of one or more head of

1 cattle or bison or one or more horses; or

2 (C) the actor causes wholly or partly impairment 3 or interruption of access to an automated teller machine, 4 regardless of the amount of the pecuniary loss;

5 (6) a felony of the second degree if the amount of 6 pecuniary loss is \$150,000 or more but less than \$300,000; or

7 (7) a felony of the first degree if the amount of8 pecuniary loss is \$300,000 or more.

9 SECTION 2. Section 28.03(g), Penal Code, is amended by 10 adding Subdivision (9) to read as follows:

11 (9) "Automated teller machine" has the meaning 12 assigned by Section 31.03.

SECTION 3. The change in law made by this Act applies only 13 to an offense committed on or after the effective date of this Act. 14 An offense committed before the effective date of this Act is 15 16 governed by the law in effect when the offense was committed, and the former law is continued in effect for that purpose. 17 For 18 purposes of this section, an offense was committed before the effective date of this Act if any element of the offense occurred 19 before that date. 20
