4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:	
5	SECTION 1. Subchapter B, Chapter 29, Education Code, is	
6	amended by adding Section 29.067 to read as follows:	
7	Sec. 29.067. STRATEGIC PLAN TO IMPROVE AND EXPAND BILINGUAL	
8	EDUCATION. (a) In this section, "general academic teaching	
9	institution" has the meaning assigned by Section 61.003.	
10	(b) The agency, in collaboration with the Texas Higher	
11	Education Coordinating Board and the Texas Workforce Commission,	
12	shall develop a strategic plan that sets tangible goals and	
13	establishes timelines to:	
14	(1) increase the number of educators certified under	
15	Subchapter B, Chapter 21, in bilingual education instruction;	
16	(2) increase the number of dual language	
17	immersion/one-way and two-way program models used in public	
18	schools;	
19	(3) educate families and school district employees	
20	regarding the importance of bilingual education in early childhood;	
21	(4) adopt a uniform process for:	
22	(A) identifying students in prekindergarten	
23	through 12th grade of limited English proficiency;	
24	(B) monitoring the bilingual learning of	

1	students in prekindergarten through 12th grade; and		
2	(C) collecting data regarding the identification		
3	and monitoring under Paragraphs (A) and (B); and		
4	(5) increase the number of bilingual and multilingual		
5	high school graduates.		
6	(c) In developing the strategic plan, the agency:		
7	(1) shall consult with appropriate representatives		
8	of:		
9	(A) general academic teaching institutions;		
10	(B) public schools;		
11	(C) early childhood education programs; and		
12	(D) parents and legal guardians of public school		
13	students;		
14	(2) may collaborate with representatives of:		
15	(A) state, regional, and local agencies;		
16	(B) nonprofit organizations;		
17	(C) social services providers;		
18	(D) faith-based organizations; and		
19	(E) the business community; and		
20	(3) shall study the use of the Bilingual Target		
21	Language Proficiency Test to certify educators in bilingual		
22	education instruction and:		
23	(A) determine:		
24	(i) the impact of using that test to assess		
25	the critical competencies necessary to instruct bilingual programs		
26	at each grade level; and		
27	(ii) if any barriers to the certification		

- 1 of bilingual educators exist based on differences between the
- 2 dialect of the educator and the dialect used on the test; and
- 3 (B) make recommendations to modify or revise the
- 4 <u>assessments used to certify educators in bilingual education</u>
- 5 instruction to enhance the competency of educators serving
- 6 bilingual programs.
- 7 (d) The agency shall submit the plan developed under this
- 8 section to the governor, the lieutenant governor, the speaker of
- 9 the house of representatives, and each member of the standing
- 10 committees of the senate and house of representatives having
- 11 primary jurisdiction over public education not later than December
- 12 1, 2022.
- 13 (e) This section expires January 1, 2023.
- 14 SECTION 2. This Act takes effect immediately if it receives
- 15 a vote of two-thirds of all the members elected to each house, as
- 16 provided by Section 39, Article III, Texas Constitution. If this
- 17 Act does not receive the vote necessary for immediate effect, this
- 18 Act takes effect September 1, 2021.
