4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter B, Chapter $12$ , Parks and Wildlife
6	Code, is amended by adding Section 12.1104 to read as follows:
7	Sec. 12.1104. REMOVAL AND DISPOSAL OF ABANDONED FISHING
8	DEVICE. (a) In this section, "abandoned fishing device" means ar
9	unattended fishing device located in the public water of this state
10	that is placed in violation of a provision of this code or
11	commission rule.
12	(b) An abandoned fishing device is litter for purposes of
13	Section 365.011, Health and Safety Code, and is subject to
14	immediate removal and disposal. Except as provided by Subsection
15	(e), an abandoned fishing device must be disposed of in compliance
16	with the Health and Safety Code.
17	(c) The commission may adopt rules to govern the removal and
18	disposal of abandoned fishing devices as necessary to enhance:
19	(1) enforcement of this section;
20	(2) the cleanliness of the beds and bottoms of the
21	<pre>public water of this state;</pre>
22	(3) boating safety; and
23	(4) the conservation and management of aquation

- 1 (d) A game warden or other peace officer is immune from
- 2 liability and from suit for the removal or disposal of an abandoned
- 3 fishing device under this section.
- 4 (e) On request of an authorized representative of a unit of
- 5 The University of Texas System, The Texas A&M University System, or
- 6 the Texas State University System engaged in teaching and research
- 7 related to marine science and oceanography, the department may
- 8 transfer an abandoned fishing device removed under this section to
- 9 the unit for use in the unit's teaching or research programs.
- SECTION 2. Section 12.1105(d), Parks and Wildlife Code, is
- 11 amended to read as follows:
- 12 (d) A game warden or other peace officer who seizes items
- 13 under this section is immune from liability and from suit for a
- 14 seizure or destruction of a seine, net, trawl, trap, or other device
- 15 as authorized by <u>Subsection (b)</u> [this section].
- SECTION 3. Section 66.102, Parks and Wildlife Code, is
- 17 amended to read as follows:
- 18 Sec. 66.102. PLACING PROHIBITED DEVICES IN PUBLIC WATER. A
- 19 device designed to catch fish or other aquatic wildlife resources
- 20 that is placed in the public fresh water of this state in violation
- 21 of a law or commission proclamation is a nuisance, and a game warden
- 22 or other peace officer shall confiscate and dispose of the device as
- 23 provided by Section 12.1104 or 12.1105, as applicable [of this
- 24 code]. A game warden or other peace officer is immune from
- 25 liability for the destruction of devices found in violation of this
- 26 section.
- 27 SECTION 4. Section 12.1105(c), Parks and Wildlife Code, is
