5	SECTION 1. The heading to Subchapter C, Chapter 2155,
6	Occupations Code, is amended to read as follows:
7	SUBCHAPTER C. FIREARMS POLICY [NOTICE]
8	SECTION 2. Section 2155.101, Occupations Code, is amended
9	to read as follows:
10	Sec. 2155.101. <u>DEFINITIONS</u> [ <del>DEFINITION</del> ]. In this
11	subchapter <u>:</u>
12	(1) "Hotel" means a hotel, motel, inn, or similar
13	business entity that offers more than 10 rooms to the public for
14	temporary lodging for a fee [, "hotel" has the meaning assigned by
15	Section 156.001, Tax Code].
16	(2) "License holder" has the meaning assigned by
17	Section 46.035, Penal Code.
18	SECTION 3. Subchapter C, Chapter 2155, Occupations Code, is
19	amended by adding Section 2155.1025 to read as follows:
20	Sec. 2155.1025. FIREARMS POLICY. (a) Unless possession of
21	a handgun or other firearm or ammunition on hotel property is
22	prohibited by state or federal law, a hotel may not adopt a policy
23	prohibiting a hotel guest who is a license holder from:
24	(1) carrying or storing a firearm or firearm

No. 637 1 ammunition in the guest's hotel room; 2 (2) carrying a firearm or firearm ammunition directly 3 en route to or from the hotel or the guest's hotel room; 4 (3) carrying a firearm or firearm ammunition directly en route to or from the guest's vehicle located on the hotel 5 property, including a vehicle in a parking area provided for hotel 6 7 quests; or (4) carrying or storing a firearm or firearm 8 ammunition in the guest's vehicle located on the hotel property, 9 10 including a vehicle in a parking area provided for hotel guests. (b) A hotel may adopt a policy requiring a hotel guest 11 12 carrying a firearm or firearm ammunition in a common area on the 13 hotel property to: 14 (1) carry a handgun in a concealed manner; or 15 (2) carry a firearm or ammunition in a case or bag. 16 SECTION 4. Section 30.05, Penal Code, is amended by adding 17 Subsection (f-4) to read as follows: (f-4) It is a defense to prosecution under this section 18 19 that: (1) the conduct occurred on hotel property, and the 20 basis on which entry on that property was forbidden is that entry 21 with a firearm or firearm ammunition was forbidden; 22 (2) the actor: 23 24 (A) holds a license to carry a handgun under 25 Subchapter H, Chapter 411, Government Code; and 26 (B) is a guest of a hotel, as defined by Section 2155.101, Occupations Code; and 27

2	(A) carries or stores a firearm or firearm

13	SECTION 5. Section 30.06, Penal Code, is amended by adding
14	Subsection (e-4) to read as follows:
15	(e-4) It is a defense to prosecution under this section that
16	the license holder is a guest of a hotel, as defined by Section
17	2155.101, Occupations Code, and the license holder:
18	(1) carries or stores a handgun in the license holder's
19	hotel room;
20	(2) carries a handgun directly en route to or from the
21	hotel or the license holder's hotel room;
22	(3) carries a handgun directly en route to or from the
23	license holder's vehicle located on the hotel property, including a
24	vehicle in a parking area provided for hotel guests; or
25	(4) carries or stores a handgun in the license holder's
26	vehicle located on the hotel property, including a vehicle in a

SECTION 6. Section 30.07, Penal Code, is amended by adding 1 Subsection (e-4) to read as follows: 2 3 (e-4) It is a defense to prosecution under this section that the license holder is a guest of a hotel, as defined by Section 4 5 2155.101, Occupations Code, and the license holder: 6 (1) carries or stores a handgun in the license holder's 7 hotel room; 8 (2) carries a handgun directly en route to or from the hotel or the license holder's hotel room; 9 10 (3) carries a handgun directly en route to or from the license holder's vehicle located on the hotel property, including a 11 12 vehicle in a parking area provided for hotel guests; or (4) carries or stores a handgun in the license holder's 13 vehicle located on the hotel property, including a vehicle in a 14 parking area provided for hotel guests. 15 SECTION 7. Sections 30.05, 30.06, and 30.07, Penal Code, as 16 17 amended by this Act, apply only to an offense committed on or after the effective date of this Act. An offense committed before the 18 19 effective date of this Act is governed by the law in effect on the date the offense was committed, and the former law is continued in 20 effect for that purpose. For purposes of this section, an offense 21 was committed before the effective date of this Act if any element 22 23 of the offense occurred before that date. 24 SECTION 8. This Act takes effect September 1, 2021.
