15	may provide for special open seasons during which the taking and
16	possession of ducks, geese, mergansers, coots, moorhens, and
17	gallinules are restricted to veterans, as defined by 38 U.S.C.
18	Section 101, and members of the armed forces of the United States on
19	active duty, including members of the national guard and reserves
20	on active duty other than for training.
21	(b) A special open season provided for by the commission
22	under Subsection (a) may be combined with a special open season
23	provided for by the commission under Section 61.058.
24	(c) The commission by rule may prescribe the proof of

veteran or active duty status required of a person to participate in
a special open season under this section.

3 (d) If the commission by rule requires that a person 4 participating in a special open season under this section have in 5 the person's immediate possession proof of the person's veteran or 6 active duty status in accordance with commission rule, the rule 7 must provide that it is a defense to prosecution under that rule 8 that the person produces in court proof of the person's veteran or 9 active duty status in accordance with commission rule.

10 SECTION 3. This Act takes effect immediately if it receives 11 a vote of two-thirds of all the members elected to each house, as 12 provided by Section 39, Article III, Texas Constitution. If this 13 Act does not receive the vote necessary for immediate effect, this 14 Act takes effect September 1, 2021.
