A BILL TO BE ENTITLED

S.B. No. 776

2	relating to the creation of an inclusive sports program by the

5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. This Act may be cited as Zariah's Law.
7	SECTION 2. Subchapter D, Chapter 33, Education Code, is
8	amended by adding Section 33.097 to read as follows:
9	Sec. 33.097. INCLUSIVE SPORTS PROGRAM FOR STUDENTS WITH
10	INTELLECTUAL DISABILITIES. (a) The University Interscholastic
11	League shall ensure students with intellectual disabilities have an
12	opportunity to participate in team athletic activities by

(b) The University Interscholastic League shall adopt rules

establishing and maintaining an inclusive sports program.

- 17 (1) accommodate inclusive team sports offered through

- 24 incorporate inclusive sports; and

1	(4) require the program to incorporate activities that
2	<pre>promote:</pre>
3	(A) bullying prevention;
4	(B) moral intelligence;
5	(C) character development;
6	(D) leadership development;
7	(E) physical fitness; and
8	(F) positive school culture.
9	(c) In adopting the rules under Subsection (b), the
10	University Interscholastic League shall consider and incorporate
11	as appropriate:
12	(1) federal guidance regarding providing access to
13	extracurricular athletics for students with intellectual
14	disabilities;
15	(2) guidance available from nationally recognized
16	organizations that promote inclusion and acceptance among students
17	with and without intellectual disabilities;
18	(3) information regarding inclusive sports programs
19	that have been successfully implemented in this state, in other
20	states, and by nonprofit organizations;
21	(4) input from school districts and the agency; and
22	(5) guidance provided by impacted stakeholders,
23	including by parents of or persons standing in parental relation to
24	students with intellectual disabilities.
25	(d) The University Interscholastic League may appoint a
26	person to provide guidance on behalf of impacted stakeholders for
27	purposes of Subsection (c)(5).

- 1 (e) In maintaining the inclusive sports program, the
- 2 University Interscholastic League shall, to the greatest extent
- 3 possible, require:
- 4 (1) students who participate in the inclusive sports
- 5 program to be subject to the same rules and requirements as students
- 6 who participate in other athletic programs offered by the league,
- 7 including:
- 8 <u>(A) grade and disciplinary requirements under</u>
- 9 <u>Section 33.081(c); and</u>
- 10 (B) requirements related to student safety in
- 11 athletic activities under this chapter and Chapter 38; and
- 12 (2) team sports provided through the inclusive sports
- 13 program to be organized similarly to other athletic programs
- 14 offered by the league, including with respect to team practices,
- 15 seasonal play, and local and statewide competitions.
- (f) In addition to using funds available or appropriated for
- 17 the purpose, the University Interscholastic League or a partner
- 18 affiliated with the league may seek and accept gifts, grants, or
- 19 donations of money from public and private sources for the purpose
- 20 of establishing or expanding the inclusive sports program.
- 21 SECTION 3. This Act takes effect September 1, 2021.
