6	SECTION 1. Subchapter A, Chapter 191, Health and Safety
7	Code, is amended by adding Section 191.00491 to read as follows:
8	Sec. 191.00491. BIRTH RECORD ISSUED TO VICTIMS AND CHILDREN
9	OF VICTIMS OF DATING OR FAMILY VIOLENCE. On request of an
10	individual described by this section, the state registrar, a local
11	registrar, or a county clerk shall issue, without payment of a fee,
12	a certified copy of the individual's birth record to:
13	(1) a victim of dating violence as defined by Section

15	(2) a victim of family violence as defined by Section
16	51.002, Human Resources Code; or
17	(3) a child of a victim described by Subdivision (1) or

19	SECTION 2. Subchapter E, Chapter 521, Transportation Code,
20	is amended by adding Section 521.1016 to read as follows:

Subsection (b) from the payment of any fee for the issuance of a 1 personal identification certificate under this chapter, subject to 2 3 Section 521.4265. 4 SECTION 3. Section 521.1811, Transportation Code, is 5 amended to read as follows: Sec. 521.1811. WAIVER OF FEES FOR FOSTER CHILD OR YOUTH, 6 [OR] HOMELESS CHILD OR YOUTH, OR VICTIM OR CHILD OF VICTIM OF DATING 7 OR FAMILY VIOLENCE. A person is exempt from the payment of any fee 8 for the issuance of a driver's license, as provided under this 9 10 chapter, if that person is: (1) younger than 18 years of age and in the managing 11 12 conservatorship of the Department of Family and Protective 13 Services; 14 (2) at least 18 years of age, but younger than 21 years 15 of age, and resides in a foster care placement, the cost of which is paid by the Department of Family and Protective Services; [or] 16 17 (3) a homeless child or youth as defined by 42 U.S.C. Section 11434a; 18 19 (4) a victim of dating violence as defined by Section 71.0021, Family Code; 20 21 (5) a victim of family violence as defined by Section 22 51.002, Human Resources Code; or 23 (6) a child of a victim described by Subdivision (4) or 24 (5). SECTION 4. Sections 521.4265(b) and (c), Transportation 25 26 Code, are amended to read as follows: (b) For each exemption granted under Section 521.1015, 27

1 <u>521.1016</u>, or 521.1811, the department shall deposit to the credit 2 of the Texas mobility fund an amount from the identification fee 3 exemption account under Subsection (a) that is equal to the amount 4 of the waived fee that would otherwise be deposited to the mobility 5 fund.

6 (c) The department may not grant an exemption under Section 7 521.1015, 521.1016, or 521.1811 if money is not available in the 8 identification fee exemption account to meet the requirements of 9 Subsection (b).

SECTION 5. The changes in law made by this Act apply to an 10 application for a birth record, driver's license, or personal 11 identification certificate submitted on or after the effective date 12 of this Act. An application for a birth record, driver's license, 13 14 or personal identification certificate submitted before the 15 effective date of this Act is governed by the law in effect on the date the application was submitted, and the former law is continued 16 17 in effect for that purpose.

SECTION 6. This Act takes effect September 1, 2021.
