(b) The comptroller by rule may provide additional 15 procedures for claiming a refund under this section. 16 SECTION 2. The change in law made by this Act does not 17 affect tax liability accruing before the effective date of this 18 Act. That liability continues in effect as if this Act had not been 19 enacted, and the former law is continued in effect for the 20
