- 8 this Act. A request for information that was received before the
- 9 effective date of this Act is governed by the law in effect on the
- 10 date the request was received, and the former law is continued in
- 11 effect for that purpose.
- 12 SECTION 7. To the extent of any conflict, this Act prevails
- 13 over another Act of the 87th Legislature, Regular Session, 2021,
- 14 relating to nonsubstantive additions to and corrections in enacted
- 15 codes.
- SECTION 8. This Act takes effect immediately if it receives
- 17 a vote of two-thirds of all the members elected to each house, as
- 18 provided by Section 39, Article III, Texas Constitution. If this
- 19 Act does not receive the vote necessary for immediate effect, this
- 20 Act takes effect September 1, 2021.
