2	commit an offense under Section 22.01(a)(1) or (3) against a person
3	the actor knew was a first responder while the person was performing
4	a duty as a first responder.
5	(h) For purposes of Subsection (g), the actor is presumed to
6	have known the person was a first responder if the person was
7	wearing a distinctive uniform or badge indicating the person's
8	status as a first responder.
9	SECTION 2. Article 42.037, Code of Criminal Procedure, is
10	amended by adding Subsection (w) to read as follows:
11	(w) The court shall order a defendant convicted of an
12	offense under Section 42.02, Penal Code, to make restitution for
13	any damage to or loss or destruction of property by reimbursing the
14	owner of the property for the cost of restoring or replacing the
15	property.
16	SECTION 3. The change in law made by this Act applies only
17	to an offense committed on or after the effective date of this Act.
18	An offense committed before the effective date of this Act is
19	governed by the law in effect on the date the offense was committed,
20	and the former law is continued in effect for that purpose. For
21	purposes of this section, an offense was committed before the
22	effective date of this Act if any element of the offense was
23	committed before that date.

24 SECTION 4. This Act takes effect September 1, 2021.
