22	treatment of a patient for glaucoma is filed with the board, the
23	board shall select at least one physician licensed in this state who
24	specializes in ophthalmology to:

- 12 therapeutic optometrists. Each member of the expert panel must be

- 17 <u>(d) An expert panel selected to review a complaint under</u>
- 18 Subsection (c) shall:
- 19 <u>(1) review the physician's determination</u> made under

- 21 (2) recommend to the board whether the therapeutic
- 22 optometrist should be subject to disciplinary action and, if so,
- 23 whether the disciplinary action should include suspension or
- 24 revocation of the therapeutic optometrist's certificate issued
- 25 under Section 351.3581(a).
- 26 (e) A person is not eligible to review a complaint under
- 27 Subsection (b) or serve on an expert panel under Subsection (c) if:

1 (1) the person or the person's spouse is an officer, employee, or paid consultant of a Texas trade association, as 2 defined by Section 351.053, in the field of health care; or 3 (2) the person is a member of the faculty or board of 4 trustees of an optometry school or an institution of higher 5 education with an affiliated school of optometry. 6 7 The board shall maintain and make publicly available online: 8 9 (1) information regarding the number of complaints filed with the board regarding the treatment of patients for 10 11 glaucoma by therapeutic optometrists and the disposition of those complaints; and 12 (2) a searchable list of each therapeutic optometrist 13 whose certificate under Section 351.3581(a) was suspended or 14 revoked by the board. 15 16 (g) This section expires September 1, 2027. 17 SECTION 2. Section 351.358(c), Occupations Code, is amended to read as follows: 18 (c) A therapeutic optometrist may prescribe not more than 19 [oral medications only in the following classifications of oral 20 21 pharmaceuticals: 22 [(1) one 10-day supply of oral antibiotics; [(2) one 72-hour supply of oral antihistamines; 23 24 (3) one seven-day supply of 25 anti-inflammatories; $[\frac{(4)}{(4)}]$ one three-day supply of 26 any medication

- 6 SECTION 3. The heading to Section 351.3581, Occupations
- 7 Code, is amended to read as follows:
- 8 Sec. 351.3581. [DIACNOSIS AND] TREATMENT OF GLAUCOMA.
- 9 SECTION 4. Sections 351.3581(a) and (d), Occupations Code,
- 10 are amended to read as follows:
- 11 (a) A therapeutic optometrist may not administer or
- 12 prescribe an oral or parenteral medication or treat glaucoma unless
- 13 the therapeutic optometrist holds a certificate issued by the
- 14 board. A therapeutic optometrist certified under this section
- 15 [subsection] shall be known as an optometric glaucoma specialist.
- 16 To obtain a certificate, a therapeutic optometrist must [as]
- 17 required under Section 351.165(c)]:
- 18 (1) complete an instructional clinical review course;
- 19 and
- 20 (2) pass an examination approved by the board.
- 21 (d) A therapeutic optometrist shall refer a patient to an
- 22 ophthalmologist if:
- 23 (1) the patient is younger than 16 years of age and has
- 24 been diagnosed as having glaucoma;
- 25 (2) the patient has been diagnosed as having acute
- 26 closed angle glaucoma;
- 27 (3) the patient has been diagnosed as having malignant

1 glaucoma or neovascular glaucoma;

- (4) the patient has definite optic disc, retinal nerve 2 fiber layer, or macular imaging abnormalities consistent with 3 glaucoma and visual field abnormalities in both hemifields, or loss 4 within five degrees of fixation in at least one hemifield as tested 5 with standard automated perimetry [therapeutic optometrist 6 7 determines that a patient's glaucoma is caused by a diabetic complication and, after joint consultation with the physician 8 9 treating the diabetes and an ophthalmologist by telephone, fax, or 10 another method, the physician or ophthalmologist determines that 11 the patient should be seen by the physician or ophthalmologist]; or (5) the therapeutic optometrist determines that a 12 13 patient's glaucoma is not responding [appropriately] nonsurgical intervention [a treatment specified in Subsection (f) 14 and, after consulting a physician by telephone, fax, or another 15 16 method, the physician determines that the patient should be seen by 17 the physician or an appropriate specialist].
- SECTION 5. Not later than December 1, 2021, the Texas
 Optometry Board shall adopt rules necessary to implement the
 changes in law made by this Act to Chapter 351, Occupations Code.
- 21 SECTION 6. Sections 351.3581(b) and (c), Occupations Code, 22 are repealed.
- 23 SECTION 7. This Act takes effect September 1, 2021.
