- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 91.401, Natural Resources Code, is
- 7 amended by adding Subdivision (5) to read as follows:
- 8 (5) "Nonparticipating royalty interest owner" means a
- 9 mineral interest owner whose interest was conveyed without the
- 10 right to negotiate lease terms or receive a bonus.
- 11 SECTION 2. Section 91.402, Natural Resources Code, is
- 12 amended by amending Subsection (a) and adding Subsection (a-1) to
- 13 read as follows:
- 14 (a) <u>In this section</u>, the term "payee" includes a
- 15 nonparticipating royalty interest owner.
- 16 (a-1) The proceeds derived from the sale of oil or gas
- 17 production from an oil or gas well located in this state must be
- 18 paid to each payee by payor on or before 120 days after the end of
- 19 the month of first sale of production from the well. After that
- 20 time, payments must be made to each payee on a timely basis
- 21 according to the frequency of payment specified in a lease or other
- 22 written agreement between payee and payor. If the lease or other
- 23 agreement does not specify the time for payment, subsequent
- 24 proceeds must be paid no later than:

- 1 (1) 60 days after the end of the calendar month in
- 2 which subsequent oil production is sold; or
- 3 (2) 90 days after the end of the calendar month in
- 4 which subsequent gas production is sold.
- 5 SECTION 3. Section 91.5001, Natural Resources Code, is
- 6 amended to read as follows:
- 7 Sec. 91.5001. <u>DEFINITIONS</u> [<u>DEFINITION</u>]. In this
- 8 subchapter:
- 9 (1) "Nonparticipating royalty interest owner" means a
- 10 mineral interest owner whose interest was conveyed without the
- 11 right to negotiate lease terms or receive a bonus.
- 12 (2) "Payor"[, "payor"] has the meaning assigned by
- 13 Section 91.401.
- 14 SECTION 4. Section 91.504, Natural Resources Code, is
- 15 amended by amending Subsection (a) and adding Subsection (a-1) to
- 16 read as follows:
- 17 (a) In this section, "royalty interest owner" includes a
- 18 nonparticipating royalty interest owner.
- 19 (a-1) If the payor does not explain on the check stub,
- 20 attachment to the payment form, or other remittance advice, or by a
- 21 separate mailing, deductions from or adjustments to payments, the
- 22 payor must provide an explanation by certified mail not later than
- 23 the 60th day after the date the payor receives a request from the
- 24 royalty interest owner. The royalty interest owner must send the
- 25 request by certified mail.
- 26 SECTION 5. Section 91.505, Natural Resources Code, is
- 27 amended to read as follows:

- 1 Sec. 91.505. PROVIDING OTHER INFORMATION. (a) In this
- 2 section, "royalty interest owner" includes a nonparticipating
- 3 royalty interest owner.
- 4 (b) If a royalty interest owner requests information or
- 5 answers to questions concerning a payment made pursuant to this
- 6 subchapter, other than information requested under Section 91.504,
- 7 and the request is made by certified mail, the payor must respond to
- 8 the request by certified mail not later than 30 days after the
- 9 request is received.
- 10 SECTION 6. The change in law made by this Act applies only
- 11 to a division order issued on or after the effective date of this
- 12 Act. A division order issued before the effective date of this Act
- 13 is governed by the law in effect on the date the division order was
- 14 issued, and the former law is continued in effect for that purpose.
- SECTION 7. This Act takes effect September 1, 2021.
