- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Chapter 18, Code of Criminal Procedure, is
- 6 amended by adding Article 18.067 to read as follows:
- 7 Art. 18.067. EXECUTION OF WARRANT FOR BLOOD SPECIMEN IN
- 8 INTOXICATION OFFENSE. Notwithstanding any other law, a warrant
- 9 <u>issued under Article 18.02(a)(10)</u> to collect a blood specimen from
- 10 <u>a person suspected of committing an intoxication offense under</u>
- 11 Section 49.04, 49.045, 49.05, 49.06, 49.065, 49.07, or 49.08, Penal
- 12 Code, may be executed:
- 13 (1) in any county adjacent to the county in which the
- 14 warrant was issued; and
- 15 (2) by any law enforcement officer authorized to make
- 16 an arrest in the county of execution.
- 17 SECTION 2. Article 18.10, Code of Criminal Procedure, is
- 18 amended to read as follows:
- 19 Art. 18.10. HOW RETURN MADE. (a) Not later than three
- 20 whole days after executing a search warrant, the officer shall
- 21 return the search warrant. Upon returning the search warrant, the
- 22 officer shall state on the back of the same, or on some paper
- 23 attached to it, the manner in which the warrant has been executed.
- 24 The officer shall also deliver to the magistrate a copy of the

- inventory of the property taken into his possession under the 1 2 warrant. The failure of an officer to make a timely return of an executed search warrant or to submit an inventory of the property 3 4 taken into the officer's possession under the warrant does not bar the admission of evidence under Article 38.23. The officer who 5 seized the property shall retain custody of it until the magistrate 6 7 issues an order directing the manner of safekeeping the property. Except as otherwise provided by Subsection (b), the [The] property 8 9 may not be removed from the county in which it was seized without an order approving the removal, issued by a magistrate in the county in 10 which the warrant was issued; provided, however, nothing herein 11 shall prevent the officer, or his department, from forwarding any 12 item or items seized to a laboratory for scientific analysis. 13
- (b) For the purposes of complying with this article, 14 property seized pursuant to a warrant executed under Article 18.067 15 16 may be removed from the county in which it was seized and returned to the county in which the warrant was issued without a court order. 17 18 SECTION 3. The change in law made by this Act applies only to a search warrant issued on or after the effective date of this 19 Act. A search warrant issued before the effective date of this Act 20 is governed by the law in effect on the date the warrant was issued, 21 and the former law is continued in effect for that purpose. 22
- 23 SECTION 4. This Act takes effect September 1, 2021.
