1 AN ACT relating to the extended registration of certain county fleet 2 3 vehicles. Δ BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Subchapter A, Chapter 502, Transportation Code, 5 6 is amended by adding Section 502.0025 to read as follows: 7 Sec. 502.0025. EXTENDED REGISTRATION OF CERTAIN COUNTY FLEET VEHICLES. (a) In this section, "exempt county fleet" means a 8 group of two or more nonapportioned motor vehicles, semitrailers, 9 10 or trailers described by Section 502.453(a) that is owned by and used exclusively in the service of a county with a population of 3.3 11 12 million or more. 13 (b) Notwithstanding the annual registration requirements of Sections 502.044(c) and 502.453(a), the department shall develop 14 15 and implement a system of registration to allow an owner of an exempt county fleet to register vehicles in the fleet for an 16 17 extended registration period of not less than one year or more than eight years. 18 (c) A system of extended registration under this section 19 20 must allow the owner of an exempt county fleet to: (1) select the number of years for registration under 21

owner's principal place of business;

- 21 BUSES; FIRE-FIGHTING VEHICLES; COUNTY MARINE LAW ENFORCEMENT
- 22 VEHICLES; U.S. COAST GUARD AUXILIARY VEHICLES. (a) The owner of a
- 23 motor vehicle, trailer, or semitrailer may [annually] apply for
- 24 registration under Section 502.0025 or 502.451 and is exempt from
- 25 the payment of a registration fee under this chapter if the vehicle
- 26 is:
- 27 (1) owned by and used exclusively in the service of:

- 1 (A) the United States;
- 2 (B) this state;
- 3 (C) a county, municipality, or school district in

- 5 (D) an open-enrollment charter school;
- 6 (2) owned by a commercial transportation company and
- 7 used exclusively to provide public school transportation services
- 8 to a school district under Section 34.008, Education Code;
- 9 (3) designed and used exclusively for fire fighting;
- 10 (4) owned by a volunteer fire department and used
- 11 exclusively in the conduct of department business;
- 12 (5) privately owned and used by a volunteer
- 13 exclusively in county marine law enforcement activities, including
- 14 rescue operations, under the direction of the sheriff's department;
- 15 (6) used by law enforcement under an alias for covert
- 16 criminal investigations; or
- 17 (7) owned by units of the United States Coast Guard
- 18 Auxiliary headquartered in Texas and used exclusively for conduct
- 19 of United States Coast Guard or Coast Guard Auxiliary business and
- 20 operations, including search and rescue, emergency communications,
- 21 and disaster operations.
- 22 (b) An application for registration under this section or
- 23 Section 502.0025 must be made by a person having the authority to
- 24 certify that the vehicle meets the exemption requirements
- 25 prescribed by Subsection (a). An application for registration
- 26 under this section of a fire-fighting vehicle described by
- 27 Subsection (a)(3) must include a reasonable description of the

- 1 vehicle and of any fire-fighting equipment mounted on the vehicle.
- 2 An application for registration under this section of a vehicle
- 3 described by Subsection (a)(5) must include a statement signed by a
- 4 person having the authority to act for a sheriff's department that
- 5 the vehicle is used exclusively in marine law enforcement
- 6 activities under the direction of the sheriff's department. An
- 7 application for registration under this section of a vehicle
- 8 described by Subsection (a)(7) must include a statement signed by a
- 9 person having authority to act for the United States Coast Guard
- 10 Auxiliary that the vehicle or trailer is used exclusively in
- 11 fulfillment of an authorized mission of the United States Coast
- 12 Guard or Coast Guard Auxiliary, including search and rescue,
- 13 patrol, emergency communications, or disaster operations.
- 14 SECTION 3. This Act takes effect September 1, 2021.
