4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. The heading to Chapter 1356, Insurance Code, is
6	amended to read as follows:
7	CHAPTER 1356. MAMMOGRAPHY AND OTHER BREAST IMAGING
8	SECTION 2. Section 1356.001(1-a), Insurance Code, is
9	amended to read as follows:
10	(1-a) "Diagnostic <u>imaging</u> [mammogram]" means an
11	imaging examination using mammography, ultrasound imaging, or
12	magnetic resonance imaging that is designed to evaluate:
13	(A) a subjective or objective abnormality
14	detected by a physician or patient in a breast;
15	(B) an abnormality seen by a physician on a
16	screening mammogram;
17	(C) an abnormality previously identified by a
18	physician as probably benign in a breast for which follow-up
19	imaging is recommended by a physician; or
20	(D) an individual with a personal history of
21	breast cancer <u>or dense breast tissue</u> .
22	SECTION 3. Section 1356.005(a-1), Insurance Code, is
23	amended to read as follows:
24	(a-1) A health benefit plan that provides coverage for a

1 screening mammogram must provide coverage for [a] diagnostic
2 <u>imaging [mammogram</u>] that is no less favorable than the coverage for
3 a screening mammogram.

4 SECTION 4. If before implementing any provision of this Act 5 a state agency determines that a waiver or authorization from a 6 federal agency is necessary for implementation of that provision, 7 the agency affected by the provision shall request the waiver or 8 authorization and may delay implementing that provision until the 9 waiver or authorization is granted.

10 SECTION 5. The change in law made by this Act applies only 11 to a health benefit plan that is delivered, issued for delivery, or 12 renewed on or after January 1, 2022. A health benefit plan that is 13 delivered, issued for delivery, or renewed before January 1, 2022, 14 is governed by the law as it existed immediately before the 15 effective date of this Act, and that law is continued in effect for 16 that purpose.

17 SECTION 6. The Texas Department of Insurance, the Employees Retirement System of Texas, the Teacher Retirement System of Texas, 18 The University of Texas System, The Texas A&M University System, 19 20 and any other state agency or institution subject to this Act are required to implement a provision of this Act only if the 21 legislature appropriates money specifically for that purpose. 22 If the legislature does not appropriate money specifically for that 23 24 purpose, those agencies may, but are not required to, implement a provision of this Act using other appropriations available for that 25 26 purpose.

27 SECTION 7. This Act takes effect September 1, 2021.
