5	SECTION 1. Subchapter C, Chapter 11, Tax Code, is amended by
6	adding Section 11.50 to read as follows:
7	Sec. 11.50. PROVISION OF NAMES OF INDIVIDUALS RECEIVING
8	RESIDENCE HOMESTEAD EXEMPTION TO ANOTHER CHIEF APPRAISER. (a) The
9	chief appraiser of an appraisal district may request that the chief
10	appraiser of another appraisal district provide to the requesting
11	chief appraiser a list of the names of all individuals who currently
12	receive an exemption for a residence homestead in the appraisal
13	district for which the request is made.
14	(b) A chief appraiser who receives a request under
15	Subsection (a) shall provide the list to the requesting chief
16	appraiser as soon as practicable.
17	(c) A provision of law making information described by
18	Subsection (a) confidential does not apply to the disclosure of
19	that information under this section to another chief appraiser.
20	SECTION 2. Sections 41.413(d) and (e), Tax Code, are
21	amended to read as follows:
22	(d) <u>An</u> [ <del>A property</del> ] owner <u>of real property</u> shall send to a
23	person leasing property under a contract described by Subsection
24	(b) [this section] a copy of any notice of appraised value of the

property received by the property owner. The property owner must 1 2 send the notice not later than the 10th day after the date the property owner receives the notice. Failure of the property owner 3 4 to send a copy of the notice to the person leasing the property does not affect the time within which the person leasing the property may 5 protest the appraised value. This subsection does not apply if the 6 7 property owner and the person leasing the property have agreed in the contract to waive the requirements of this subsection or that 8 9 the person leasing the property will not protest the appraised 10 value of the property.

11 (e) A person leasing <u>real</u> property under a contract described by Subsection (b) [this section] may request that the 12 13 chief appraiser of the appraisal district in which the property is located send the notice described by Subsection (d) to the person. 14 15 Except as provided by Subsection (f), the chief appraiser shall 16 send the notice to the person leasing the property not later than the fifth day after the date the notice is sent to the property 17 owner if the person demonstrates that the person is contractually 18 obligated to reimburse the property owner for the taxes imposed on 19 20 the property.

21 SECTION 3. The changes in law made by this Act apply only to 22 a notice of appraised value received by a property owner on or after 23 the effective date of this Act.

SECTION 4. This Act takes effect September 1, 2021.
