5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. This Act may be cited as the Christine Blubaugh
7	Act.
8	SECTION 2. Section 28.002, Education Code, is amended by
9	adding Subsection (u) to read as follows:
10	(u) The State Board of Education shall adopt rules requiring
11	students to receive instruction on the prevention of child abuse,
12	family violence, and dating violence at least once in middle or
13	junior high school and at least twice in high school. The
14	instruction must include information on:
15	(1) the dating violence policy adopted by the
16	student's school district under Section 37.0831;
17	(2) the prevalence of dating violence and the
18	recognition of abuse warning signs;
19	(3) the procedures for reporting violence or abuse;
20	and
21	(4) educational materials or resources available to
22	students under Section 37.0831(c).
23	SECTION 3. The heading to Section 37.0831, Education Code,
24	is amended to read as follows:

1 Sec. 37.0831. DATING POLICIES; EDUCATIONAL VIOLENCE 2 MATERIALS AND RESOURCES. SECTION 4. Section 37.0831, Education Code, is amended by 3 amending Subsection (b) and adding Subsection (c) to read as 4 follows: 5 (b) A dating violence policy must: 6 7 (1)include: (A) a definition of dating violence that includes 8 9 the intentional use of physical, sexual, verbal, or emotional abuse by a person to harm, threaten, intimidate, or control another 10 11 person in a dating relationship, as defined by Section 71.0021, Family Code; 12 13 (B) a clear statement that dating violence is not 14 tolerated at school; 15 (C) reporting procedures and guidelines for 16 students who are victims of dating violence; and 17 (D) information regarding the instruction on the prevention of dating violence required under Section 28.002(u); and 18 (2) address safety planning, 19 enforcement of 20 protective orders, school-based alternatives to protective orders, training for teachers and administrators, counseling for affected 21 students, and awareness education for students and parents. 22 (c) To the extent possible, a school district shall make 23 available to students: 24 25 (1) age-appropriate educational materials that include information on the dangers of dating violence; and 26 27 (2) resources to students seeking help.

SECTION 5. This Act applies beginning with the 2021-2022
school year.

3 SECTION 6. This Act takes effect immediately if it receives 4 a vote of two-thirds of all the members elected to each house, as 5 provided by Section 39, Article III, Texas Constitution. If this 6 Act does not receive the vote necessary for immediate effect, this 7 Act takes effect September 1, 2021.
