2	relating to the establishment of a task force on ensuring an
3	appropriate care setting for a person with a disability.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter B, Chapter 531, Government Code, is
6	amended by adding Section 531.02441 to read as follows:
7	Sec. 531.02441. INTERAGENCY TASK FORCE ON ENSURING
8	APPROPRIATE CARE SETTINGS FOR PERSONS WITH DISABILITIES. (a) The
9	executive commissioner shall establish an interagency task force to
10	assist the commission and appropriate health and human services
11	agencies in developing a comprehensive, effectively working plan to
12	ensure appropriate care settings for persons with disabilities.
13	(b) The executive commissioner shall determine the number
14	of members of the task force. The executive commissioner shall
15	appoint as members of the task force:
16	(1) representatives of appropriate health and human
17	services agencies;
18	(2) representatives of related work groups;
19	(3) representatives of consumer and family advocacy
20	groups; and
21	(4) representatives of service providers for persons
22	with disabilities.
23	(c) The executive commissioner shall designate a member of

the task force to serve as presiding officer. The members of the

- 1 task force shall elect any other necessary officers.
- 2 (d) The task force shall meet at the call of the executive
- 3 <u>commissioner.</u>
- 4 (e) A member of the task force serves at the will of the
- 5 executive commissioner.
- 6 (f) A member of the task force may not receive compensation
- 7 for serving on the task force but is entitled to reimbursement for
- 8 travel expenses incurred by the member while conducting the
- 9 business of the task force as provided by the General
- 10 Appropriations Act.
- 11 (g) The task force shall study and make recommendations to
- 12 the commission on developing the comprehensive, effectively
- 13 working plan required by Section 531.0244(a) to ensure appropriate
- 14 care settings for persons with disabilities.
- 15 (h) In addition to making recommendations under Subsection
- 16 (g), the task force shall advise the commission and appropriate
- 17 health and human services agencies with respect to implementing the
- 18 comprehensive, effectively working plan required by Section
- 19 531.0244(a), giving primary consideration to:
- 20 (1) methods to identify and assess each person who
- 21 resides in an institution but chooses to live in the community and
- 22 for whom a transfer from an institution to the community is
- 23 appropriate, as determined by the person's treating professionals;
- 24 (2) determining the health and human services
- 25 agencies' availability of community care and support options
- 26 relating to all persons described by Subdivision (1);
- 27 (3) identifying, addressing, and monitoring barriers

- 1 to implementation of the plan to improve that implementation; and
- 2 (4) identifying funding options for the plan.
- 3 (i) Not later than September 1 of each year, the task force
- 4 shall submit a report to the executive commissioner on its findings
- 5 and recommendations required by Subsection (g).
- 6 (j) The task force is abolished and this section expires
- 7 <u>September 1, 2025.</u>
- 8 SECTION 2. Not later than December 1, 2021, the executive
- 9 commissioner of the Health and Human Services Commission shall
- 10 establish the interagency task force under Section 531.02441,
- 11 Government Code, as added by this Act.
- 12 SECTION 3. This Act takes effect September 1, 2021.
