- 2 relating to the establishment of a task force to evaluate
- 3 state-owned artifact collections.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. DEFINITION. In this Act, "task force" means the
- 6 task force established under Section 2 of this Act.
- 7 SECTION 2. ESTABLISHMENT OF TASK FORCE. A task force is
- 8 established to manage artifact collections owned by this state.
- 9 SECTION 3. TASK FORCE MEMBERSHIP. (a) The task force is
- 10 composed of representatives of the:
- 11 (1) Texas Historical Commission;
- 12 (2) General Land Office;
- 13 (3) Texas State Library and Archives Commission;
- 14 (4) Parks and Wildlife Department;
- 15 (5) State Preservation Board; and
- 16 (6) Texas Facilities Commission.
- 17 (b) The executive director of each state agency represented
- 18 on the task force shall appoint an employee of the agency to serve
- 19 as the agency's representative on the task force not later than
- 20 October 1, 2021.
- 21 (c) The member representing the Texas Facilities Commission
- 22 must have engineering and architectural expertise.
- SECTION 4. REIMBURSEMENT FOR EXPENSES. A member of the task
- 24 force is not entitled to compensation for service on the task force

- 1 but is entitled to reimbursement for travel expenses incurred by
- 2 the member while conducting the business of the task force as
- 3 provided by the General Appropriations Act.
- 4 SECTION 5. DUTIES OF TASK FORCE. For each state agency
- 5 represented on the task force, the task force shall:
- 6 (1) evaluate the need for a separate collections
- 7 facility for the agency and compare use of a separate collection
- 8 facility to a secure centrally located joint collections facility
- 9 with a processing laboratory for repair, cleaning, re-housing, and
- 10 light conservation of state artifacts, including cost estimates for
- 11 maintaining a separate collections facility for each agency
- 12 compared to a joint collections facility;
- 13 (2) analyze the storage capacity for the agency's
- 14 collections to determine whether the agency's collections facility
- 15 is adequate for the agency's successful stewardship of its
- 16 collections over the next five years and 10 years;
- 17 (3) review the option of establishing a
- 18 disaster-secure collections facility with separate storage areas
- 19 for each agency;
- 20 (4) review the recommendations in the Texas Historical
- 21 Commission's December 2018 response to the Sunset Advisory
- 22 Commission decisions on creating a searchable public catalog of
- 23 state-owned collections to determine cost estimates for
- 24 implementing the recommendations and a process for implementing the
- 25 recommendations; and
- 26 (5) assess any unmet need of the agency regarding
- 27 state-owned collections as determined by the task force.

- 1 SECTION 6. REPORT. Not later than December 1, 2022, the
- 2 task force shall report the task force's findings and
- 3 determinations under Section 5 of this Act to the governor,
- 4 lieutenant governor, speaker of the house of representatives, and
- 5 standing committees of each house of the legislature with primary
- 6 jurisdiction over the history and culture of this state.
- 7 SECTION 7. EXPIRATION. The task force is abolished and this
- 8 Act expires September 1, 2023.
- 9 SECTION 8. EFFECTIVE DATE. This Act takes effect September
- 10 1, 2021.
