4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subtitle B, Title 4, Health and Safety Code is
6	amended by adding Chapter 241(B) to read as follows:
7	CHAPTER 241B. RIGHT TO ESSENTIAL CAREGIVER VISITS FOR CERTAIN
8	HOSPITAL PATIENTS
9	Sec. 241B.0001. DEFINITIONS. In this chapter:
10	(1) "Essential caregiver" means a family member,
11	friend, or other individual selected by a facility patient for
12	in-person visits.
13	(2) "Executive commissioner" means the executive
14	commissioner of the Health and Human Services Commission.
15	(3) "Hospital" includes general hospital and special
16	hospital licensed under Chapter 241.
17	(4) "Patient" means a person who, to receive medical
18	care, consults with or is seen by a physician.
19	(5) "Child" or "Minor" means a person under 18 years of
20	age who is not and has not been married or who has not had the
21	disabilities of minority removed for general purposes.
22	(6) "Parent" has the meaning assigned under Section
23	101.024, Family Code.

Sec. 241B.0002 PATIENT'S RIGHT TO ESSENTIAL CAREGIVER

- 1 VISITS. (a) A hospital patient has the right to designate at least
- 2 one essential caregiver with whom the hospital may not prohibit
- 3 in-person visitation.
- 4 (b) In the case of a patient who is a minor, the hospital must
- 5 designate as an essential caregiver:
- 6 (1) any parent that has not had their rights limited by
- 7 <u>a court; and</u>
- 8 (2) any person with conservatorship over the minor that
- 9 has not been limited by a court.
- 10 (c) Notwithstanding Subsections (a) and (b), the executive
- 11 commissioner by rule shall develop guidelines to assist hospitals
- 12 in establishing essential caregiver visitation policies and
- 13 procedures. The guidelines must require hospitals to:
- 14 (1) allow patients to designate for in-person
- 15 visitation at least one essential caregiver, and more than one if
- 16 needed;
- 17 (2) establish a visitation schedule allowing the
- 18 essential caregiver to visit the patient for the greater of two
- 19 hours each day or the hours necessary for the caregiver to complete
- 20 all caregiving tasks;
- 21 (3) establish procedures to enable personal contact
- 22 between the patient and essential caregiver;
- 23 (4) obtain a signed acknowledgment from the essential
- 24 caregiver in which the caregiver agrees to follow the hospital's
- 25 safety protocols.
- 26 (d) In the event of a conflict between this section and any
- 27 other law, this section prevails.

- 1 SECTION 2. As soon as practicable after the effective date of
- 2 this Act, the executive commissioner of the Health and Human
- 3 Services Commission shall establish the guidelines required by
- 4 Sections 241B.0002, Health and Safety Code, as added by the Act.
- 5 SECTION 4. This Act takes effect September 1, 2021.
