- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 1003.051, Special District Local Laws
- 6 Code, is amended to read as follows:
- 7 Sec. 1003.051. BOARD. The district is governed by a board
- 8 of <u>five</u> [seven] directors.
- 9 SECTION 2. Section 1003.052(a), Special District Local Laws
- 10 Code, is amended to read as follows:
- 11 (a) Unless a four-year term is established under Section
- 12 285.081, Health and Safety Code:
- 13 (1) directors serve staggered terms of two years;
- 14 (2) two [three] directors shall be elected in
- 15 odd-numbered years and three [four] directors shall be elected in
- 16 even-numbered years; and
- 17 (3) a directors election shall be held on the first
- 18 Saturday in May of each year to elect the appropriate number of
- 19 directors.
- 20 SECTION 3. (a) At the election for directors of the Booker
- 21 Hospital District to be held on May 7, 2022, five directors shall be
- 22 elected. The three directors who receive the three highest number
- 23 of total votes cast at the election shall serve two-year terms and
- 24 the two directors who receive the fourth and fifth highest number of

- 1 total votes cast at the election shall serve one-year terms.
- 2 (b) Notwithstanding Section 1003.051, Special District
- 3 Local Laws Code, as amended by this Act, the seven directors serving
- 4 on the board of directors immediately before the effective date of
- 5 this Act continue to serve as the district's governing body until a
- 6 majority of the directors elected on May 7, 2022, take office, and
- 7 the former law is continued in effect for that purpose. The terms
- 8 of the directors serving on the board of directors immediately
- 9 before the effective date of this Act expire on the date a majority
- 10 of the directors elected on May 7, 2022, take office.
- 11 (c) Service on the board of directors of the district before
- 12 May 7, 2022, does not make a person ineligible for election as a
- 13 director of the district at the election held on May 7, 2022, or at a
- 14 subsequent election of district directors.
- 15 SECTION 4. This Act takes effect September 1, 2021.
