5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subchapter C, Chapter 61, Education Code, is
7	amended by adding Section 61.07763 to read as follows:
8	Sec. 61.07763. GRANTS FOR ALTERNATIVE FINANCIAL AID PLANS.
9	(a) Using funds described by Subsection (d), the board shall award
10	grants to eligible institutions of higher education for the
11	provision of student financial assistance in accordance with this
12	section.
13	(b) The board shall develop a competitive application
14	process to award grants to eligible institutions of higher
15	education under this section. In awarding grants, the board shall
16	consider the potential of proposals to use financial aid funds to
17	effectively achieve desired purposes and outcomes identified by the
18	board or targeted by a proposal. The board shall make a reasonable
19	effort to ensure that the selected institutions are geographically
20	diverse and serve students that represent the demographic diversity
21	of this state.
22	(c) To be eligible to receive a grant under this section, an
23	institution of higher education must adopt a plan to provide
24	financial assistance to students enrolled at the institution using

1	the grant funds. The plan must:
2	(1) provide that only students who meet the financial
3	need requirements as defined by the board are eligible to receive
4	financial assistance; and
5	(2) require a student receiving financial assistance
6	to use the funds only for costs associated with attending the
7	institution, as identified by the institution.
8	(d) The board may use a portion, not to exceed three
9	percent, of the funds appropriated for the TEXAS grant program
10	under Subchapter M, Chapter 56, and a portion, not to exceed three
11	percent, of the funds appropriated for the Texas Educational
12	Opportunity Grant Program under Subchapter P, Chapter 56, for
13	purposes of this section.
14	(e) The board shall include in its annual report to the
15	legislature on financial aid in this state a report on the
16	effectiveness of the student financial assistance plans funded by
17	grants awarded under this section and any recommendations for
18	legislative or other action.
19	(f) The board may adopt rules as necessary to implement this
20	section.
21	SECTION 2. The Texas Higher Education Coordinating Board
22	shall award grants under Section 61.07763, Education Code, as added
23	by this Act, beginning with the 2023-2024 academic year.
24	SECTION 3. The Texas Higher Education Coordinating Board
25	shall include the board's initial report required under Section
26	61.07763(e), Education Code, as added by this Act, in the board's
27	annual report to the legislature on financial aid in this state
