7	SECTION 1. Subchapter M, Chapter 403 , Government Code, is
8	amended by adding Section 403.3022 to read as follows:
9	Sec. 403.3022. FARM AND RANCH SURVEY. (a) The comptroller
10	shall conduct an annual farm and ranch survey for purposes of
11	estimating the productivity value of qualified open-space land as
12	part of a study under Section 403.302.
13	(b) The comptroller shall prepare and issue an
14	instructional guide that provides information to assist
15	individuals in completing the farm and ranch survey. The
16	instructional guide must include:
17	(1) definitions of words related to property appraisal
18	in the survey;
19	(2) instructions and examples regarding how to answer
20	the questions in the survey;
21	(3) answers to frequently asked questions; and
22	(4) any other information the comptroller determines
23	is necessary to assist individuals in completing the survey.
24	(c) At least once each year, the comptroller shall conduct

an online or in-person informational session that is open to the 1 2 public regarding how to complete the farm and ranch survey. The 3 comptroller shall post a recording of the informational session on 4 the comptroller's Internet website. 5 (d) At least once each year, the comptroller shall solicit comments from the public and the property tax administration 6 7 advisory board for the purposes of: 8 (1) determining the ease and understandability of the 9 farm and ranch survey; and (2) ensuring that the questions in the survey are 10 11 designed to generate reliable answers. (e) The chief appraiser of each appraisal district shall 12 13 distribute the farm and ranch survey instructional guide to the members of the agricultural advisory board for the appraisal 14 district appointed under Section 6.12, Tax Code, and shall provide 15 16 information to the board regarding how to access the informational session provided under Subsection (c) of this section. The chief 17 18 appraiser may distribute the instructional guide electronically under this subsection. 19 20 (f) The comptroller shall distribute the farm and ranch survey instructional guide to individuals who receive the farm and 21 ranch survey from the comptroller and shall provide information to 22 23 those individuals regarding how to access the informational session provided under Subsection (c). The comptroller may distribute the 24 25 instructional guide electronically under this subsection. (g) The definitions of words related to property appraisal 26

27 included in the instructional guide are for informational purposes

1 only and do not apply to this code or the Tax Code.

2 SECTION 2. Not later than January 1, 2022, the comptroller 3 shall prepare and issue the instructional guide required by Section 4 403.3022, Government Code, as added by this Act.

5 SECTION 3. This Act takes effect September 1, 2021.
